Bids must be accompanied with E.M.D. (Bid Security) of the amount specified for the work in the table Col.6 above in shape of N.S.C./P.O.T.D / Post Office Savings Pass Book / Deposit receipt of any Scheduled Bank (Valid minimum one year from the date of receipt) duly pledged in favour of **Block Development Officer, Sadar, Keonjhar**. Bids without E.M.D. or in other shape will not be considered and liable for rejection.

N.B:- E.M.D. in shape of Cash / Pay Orders or Bankers Cheques / Bank Draft is not acceptable.

Bids shall be received by this Agency up to **1.00 PM on date 22-04-2021** through Registered Post/ Speed Post only. The authority will not be held responsible for any Postal delay in delivering of the Bid documents or non-receipt of the same.

- The Bid will be opened on Dt **23-04-2021 at 11.00 A.M.** in the office of the undersigned in the presence of the members of the District Level Tender/ Purchase Committee and the bidders or their authorised representative. If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue.
- Bidders are requested to submit the bid document along with the deposit the requisite non-refundable fees as mentioned in **Col. 7** in shape of Demand Draft drawn in favour of **Block Development Officer, Sadar, Keonjhar** payable at Sadar, Keonjhar from any Nationalized scheduled Bank towards cost of tender paper . This is non-refundable..
- Balance Bid security @ 1% of contract value shall be pledged in parts in favour of **Block Development Officer, Sadar, Keonjhar** corresponding to the respective value of works and deposited during drawl of agreement.
- Bidders shall submit original affidavit regarding authenticity of their documents and E.M.D along with their bids. Bids shall be accompanied with attested true copy of valid registration certificate, valid GSTIN clearance certificate and PAN card, otherwise his/her bids shall be declared as non-responsive and thus liable for rejection. The original certificates of the lowest two bidders are to be produced before Executive Engineer, DRDA, Keonjhar for verification.
- Other details can be seen in the bidding documents.
- Checklist is to be duly filled in.
- Engineer Contractors desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.
- The ST/SC contractor desires to avail price preference will have to deposit the Additional performance security before commencement of Agreement otherwise the bid will not be taken into consideration and liable for reject.

11. **Additional performance Security Deposit:**
The affidavit in lieu of APS will be submitted by the Successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (Vide Works Department Letter No-13286/Dated 07-09-2017, Govt of Odisha, Works Department)
12. **Forfeiture:** The EMD amount will be forfeited if the tenderer backs out from the offer acceptance of tender by the competent authority.
13. Conditional tender will summarily be rejected.
14. If the rate quoted by the bidder is more than (14.99% less) of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concern Block Development Officer and the tender committee will remain present.
15. The authority reserves the rights to reject any or all the bids without assigning any reason thereof.
