The quotation will be received in the office of the undersigned on or before 29.08.2018 up to 5.00 PM through speed post / Registered post only and the quotation will be opened on the same day at 5.30 PM in presence of the quotationer or their authorized representatives and purchase committee members of DRDA, Keonjhar. Incomplete quotation and received beyond the schedule date and time shall not be entertained and will be liable for rejection by the Purchase Committee of DRDA, Keonjhar.

TERMS AND CONDITIONS,

A) The interested offset Printing presses may inspect the sample copy of the LOGO in the office of the DRDA, Keonjhar in any working days from 10 AM to 5 PM beyond the holidays.

B) The quotationer must prepare the quotation in his letter head containing GISTIN No Contact Number, Email ID, Registration no. of the unit and attach the above documents under the seal and signature of the proprietor of the Printing Presses. The Top of the Envelop clearly super-scribe in bold letter " QUOTATION FOR PRINTING & SYPLY OF LOGO

C) The quotationer is to deposit a sum of Rs. 5,000/- (Rupees five thousand) only in shape of NSC pledge in favour of the PD, DRDA, Keonjhar towards EMD which will be adjusted towards security in case of successful quotationer and the EMD of all others will be returned to the un-successful firms within a week.

D) The successful quotationers shall execute an agreement with the Project Director, DRDA, Keonjhar within three days from the date of finalization of the quotation failing which the preference shall be given to the 2nd lowest.

E) The successful quotationer shall submit a proof copy of LOGO in complete design before the Addl. Project Director (Technical) of DRDA,Keonjhar for verification of correctness, addition & alternation if any .

F) The approved printing press shall supply the LOGO to DRDA, Keonjhar within three days from the placement of indent and submit bill for payment. No advance payment shall be paid.

G) Any loss and damage during the course of transportation shall be borne by the supplier.


