

**PROCEEDINGS OF THE 7TH DMF TRUST BOARD MEETING HELD ON
27.06.2018 AT 10.30 AM IN DURBAR HALL, COLLECTORATE, KEONJHAR.**

The 7th Trust Board Meeting of DMF was held on 27.06.2018 at 10.30 AM in Durbar Hall, Collectorate, Keonjhar under the chairmanship of Sri Ashish Thakare, IAS, Collector-cum-Managing Trustee, DMF. The list of participants is enclosed in the Annexure-I.

At the outset, the Collector welcomed all the members and participants who attended the meeting. P.D., DRDA-cum-Chief Executive, DMF elaborated the list of projects approved in the last Trust Board meeting held on 25.11.2018 and the corresponding proceedings sent to all members & unanimously, it was confirmed and approved by the members.

Then as per agenda notes, various issues were discussed sequentially. In the first instance, the deletion and inclusion of villages as per the letter of Odisha Space Application Centre (ORSAC) was discussed. As such, currently 491 villages have been identified as mining affected villages which are coming under 10 KMs radius. Recently ORSAC (as per letter No. 3613 Dtd. 21.11.2017 of Scientist, ORSAC) has identified 94 villages to be deleted as these are situated outside the 10 KM radius of the mining operation and further suggested to include 106 villages in the list. In this connection, Mr. Basudev Naik, member, suggested that before deleting the said list of villages as pointed out by the ORSAC, it should be verified in the field again. Accordingly, the Board unanimously decided to set up a technical committee to ascertain the real position and recommend further action.

The Power Point prepared by the PMU was presented in the house. The receipt of funds under DMF, its utilisation, approval of projects & sanction of funds as on 20.06.2018 is as follows:

Total Receipt of funds:	Rs.1696.73 crores
Sanction of funds:	Rs.1057.00 crores
Utilisation of funds:	Rs. 183.55 crores

The rate of expenditure of funds by the Executing Agencies was found to be very low in comparison to the funds sanctioned. All the Executing agencies explained that due to established procedure of obtaining technical sanction from higher authorities at State Hdqrs., floating of tenders and finalisation of contractors coupled with the shortage of staff at field level, the pace of expenditure is low. Collector-cum-Managing Trustee advised all the E/As to make correspondence to their administrative departments for deployment of

more field level staff for speedy execution of the projects as done by the RWSS organisation.

Hon'ble MLA, Mayadhar Jena requested the Collector to construct Model AWC building in mining affected areas. Collector directed the Executive Engineer, DRDA, Keonjhar to prepare a standard estimate for model AWC building of mining affected areas with additional provisions like play area , equipments etc.

Then, the Project Director, DRDA-cum-Chief Executive, DMF, invited all the Executing Agencies to brief their progress of work to the house.

EE, Keonjhar R&B Division, Keonjhar.

The EE, R&B Division, Keonjhar on behalf of the Division briefed the status of all the projects taken up by their organisation under DMF. He mentioned that due to difficulties faced in land acquisition, forest clearance and utility shifting, the progress of road works is delayed. To this, the Divisional Forest Officer, Keonjhar assured that as per provisions, the forest clearance shall be issued expeditiously.

The Executive Engineer also mentioned that a GIS survey of all the roads of mining affected areas is complete and Road Master Plan has been prepared to be taken up out of DMF. The Road master plan has also been approved by the Govt. and the Collector will finalise the Priority List & the Executing agencies for taking up the roads under the Master Pan. Collector requested the EE, R&B, Keonjhar to hand over the copy of the Master Plan to all Trust Board members for their information, once finalised.

Collector also advised the EE, R&B, Keonjhar to deploy more field staff including special staff for land acquisition/forest clearance to expedite the projects under DMF and state budget.

EE, Keonjhar RWS&S Division, Keonjhar.

The EE, Keonjhar RWS&S Division, Keonjhar briefed the house about the progress of works taken up. He said that as per Govt. have approved the proposal to supply safe drinking water to each household of the district through individual tap connection. In this regard, an Integrated Mega Water Supply programme covering all Blocks except Telkoi & Patna is under DPR preparation stage and will be implemented at an estimated cost Rs.1368.65 crores, out of which DMF will bear Rs.709.00 crores and the rest shall be met out of OMBADC. For Patna & Telkoi Block, barrage under "Basudha" scheme will be taken up for supply of drinking water and will be fully funded from the state plan. Then the EE, RWS&S, Keonjhar gave the current status of the DMF

projects. In this regard, he mentioned the hydro-geological challenges faced in Joda Block.

Divisional Forest Officer, Keonjhar/Anandapur.

DFO, Keonjhar briefed the progress of work taken up under DMF. He said that the following projects have been taken up by him.

1. Eco Tourism at Anjar.
2. Silviculture at Sidha Math area.
3. Urban Plantation at Barbil.

Further he proposed to develop a Medicinal Plant Conservation Centre at Anjar at the RPRC area which was previously developed by the Horticulture department. Since the RPRC has been shifted and working no more, to better utilise the facility, the project is proposed. In the said proposal the conservation of different medicinal plants from Gandhamardan Hills and other areas of the district shall be carried out.

DFO, Keonjhar Wildlife Division, Anandapur also added that the Collector & team had visited Dangadhar, a remote village of Rasol GP of Harichandanpur Block. He said the village is unconnected and a new metallic /fair-weather road connecting Pancham to Naradangi (16 KM) is required to be taken up with construction of 8 causeways and one bridge. He requested the house to consider the approval of the proposal in the interest of the unconnected tribals inhabitants. He also narrated a proposal under the caption "Silvi-horticultural Crop" in that area which will improve income generation and provide livelihood support to the local tribals and ensure proper use of land of people in whose favour FRA Pattas is in the process of being issued. The P.D.-cum-Chief Executive also added that since the rights granted under FRA is permanently heritable and not transferable, improvement of land through horticultural plantation will support to their livelihood.

Collector asked the D.F.O., Keonjhar & Anandapur to formulate plan for above mentioned proposals and submit to DMF for approval.

EE, RWD-I & II Division , Keonjhar& Anandapur Division.

Both the executive Engineer briefed the status of projects taken up under DMF.

The Collector mentioned that, as a policy, DMF will focus on construction of new roads and expansion/widening of existing roads and will avoid improvement/ repair/maintenance of existing roads. The later is to be taken up by the concerned department from the State Budget.

Then, one by one all other executing agencies briefed the status of projects taken up under DMF. The D.P.C., SSA, Keonjhar was asked to be

vigilant during roof casting of additional class rooms taken up under DMF and was instructed to expedite the bills pending at his level. Collector also explained the proposal to enhance the MDM scheme by including additional items in the menu. While the Hon'ble M.P.(Lok sabha) proposed the introduction of milk under MDM, Collector assured that all options will be looked into and decision will be taken considering the nutritional value logistical convenience. The B.D.O.s were asked to complete the AWCs sanctioned immediately and also verify the functioning of Lift irrigation points established under DMF and take suitable livelihood activities. The EE, MI, Anandapur was requested to submit the revised estimate for the renovation of 5 MI projects previously approved by the Trust Board. The E.O., Barbil Municipality was asked to submit the estimate for "Wushu sports complex" at the earliest.

Health

Collector appraised the members regarding the initiative taken to hire contractual Doctors under DMF to fill the existing vacancy of different health institutions in mining affected areas. Further, Collector advised the CDM&PHO to deploy paramedics and procure necessary equipments under DMF for the optimal functioning of the health facilities. He also mentioned that Barbil CHC will be upgraded to CHC+ with enhanced medical facilities.

Approval of Annual Report.

The annual report for the year 2016-17 along with the audit report for the year 2017-18 were placed in the Trust Report and was approved. .

Approval of new Projects.

Collector intimated regarding 57 No.s of new proposals to the members all of which was unanimously approved. The list of proposals are placed at Annexure-2.

Deletion of approved projects.

The 21 No.s of projects approved earlier were proposed to be deleted due to lack of need or feasibility and was approved. The list is placed at Annexure-3.

At last the Hon'ble M.L.A., Sadar proposed to engage Primary teachers in the remote primary schools where shortage of teachers is prevailing. In this connection the Collector asked the D.P.C., SSA, Keonjhar to supply a comprehensive vacancy position of teachers to the PMU in order to develop suitable solutions. Sri Basudev Naik, member, requested the Collector to expedite the execution of works by different executing agencies so as to enhance the pace of expenditure & early completion of the projects.

The P.D., DRDA-cum-C.E. thanked all the members and participants for their valuable suggestions and at last the meeting ended with a vote of thanks to the Chair.
