Sealed Tender are invited from the intending Registered Sports Firms / Supplier/ Co-Operative / DIC Regd. Units/ for supply of Sports, Dress, Shoes materials etc for Sports Hostel, Keonjhar for the year 2018-2019

Terms & Conditions

1. The Tender will be received by the I/C Sports Hostel, Keonjhar (Sankarpur) on behalf of the Collector, Keonjhar till **12:00 Noon** on or before **09.11.2018** and will be opened on Dated- **09.11.2018** at **3:00 PM** in the presence of suppliers or their authorized representatives by the Chairman of Tender Committee, Keonjhar in the Office Chamber of the Additional District Magistrate, Keonjhar .
2. The firm should produce quality and branded samples/products of Tracksuit, Shorts and Banians, Shoes Material, Game shoes and shocks and Kit bag to the ceiling limit of rate fixed by the Sports Department. For other articles like Game Equipments, cots, Bed sheets, Mosquito Net, Blanket, Dining Table etc. Rate shall be quoted by the firms, including all Taxes and Transporting charges with un-loading till delivery at Sports Hostel, Keonjhar (Sankarpur). The articles shall be selected/ finalized by the Tender Committee on the basis of sample test of Good quality, reputed brand of the materials only.
3. The Tender paper should be filed in properly by the firm without correction/overwriting. The rate quoted by the tender should be final and the firm should not be allowed to change anything under any circumstances. The Tender paper should be completed in all respects. Incomplete tender paper is liable to be rejected.
4. The firm should produce the Photocopy of the following documents/ papers. If authority desires to know the genuineness of the documents/ papers those should be produced in original for confirmation. The firm should have been registered under sales Tax Act, 1947 Rule-9 & 9(A) of the said Act. The Sales Tax / VAT / GST Clearance up to date in proper Form obtained from the competent authority should be attached to the Tender Form. The firm should possess Income Tax & PAN Card and enclosed the copies of the same with the Tender Form.
5. The firm are required to deposit the EMD Amount of **Rs. 10,000/- (Rupees Ten Thousand)** only in shape of Bank Draft drawn in favour of Coach In-Charge, Sports Hostel, Keonjhar along with the Quotation documents (subject to refund of the same to the unsuccessful Quotationers) after selection/ finalization by the Tender Committee.
6. The firm should produce the sample of materials before the Tender Committee on the day of Opening the Tender. Without sample the firm shall not be taken into consideration.
7. Successful Supplier should maintain the quality of materials while supplying the material as per sample approval by the Tender Committee.
8. In absence of any documents or sample as above the Tender Paper will be liable for rejection by the Tender Committee. The Firm should produce the authorization certificate of the particular brand for which he has quoted rate.
9. The Authority reserves the right to accept or reject any or all the tenders without assigning any reason thereof.

10. The Tender paper received after due date and time as well as without EMD and other required documents shall not be taken into consideration.
11. The Sealed Tender paper will be received in a sealed Box kept in the Office of the I/C Sports Hostel, Keonjhar (Sankarpur) during Office hour i.e., 10:00 AM to 5:00 PM.
12. In case of any complaint regarding the supplied materials the decision of the Collector, Keonjhar shall be binding and final. Who shall obtain a report from the recipients then the suppliers shall be replace the same at his/ her own cost.
13. If the supplier failed to supply the material within the stipulated period and as per the approved samples, the EMD will be forfeited and the purchase order will be cancelled.
14. The rate quoted should be valid up to 31.03.2019.
15. "SPORTS HOSTEL, KEONJHAR" should be printed on the back side of the upper part of the supplied Tracksuits & Banions.
16. The following Sports goods are to be purchased. But purchase order shall be placed as actual requirement as well as availability of funds, Trainees strength & actual size. The selected quotationers should supply the materials in the office of the I/C Sports Hostel, Keonjhar (Sankarpur) within 20 days (Twenty days) from the date of issue of supply orders, strictly as per the sample approved by the purchase committee.
