



Quotations received after the scheduled date and time will not be entertained.

3. Rate quoted shall be valid for at least one year. The lower rate for each item quoted by the bidder shall be taken into consideration.
4. Address to which the bids to be sent:- District Election Office, Keonjhar
5. Place of deposit of sealed quotations if submitted in person:- Tender box placed in the District Election Office, Keonjhar (The Box will be made available during the Office hours on the working days till 3.00 PM on 22.01.2019
6. The quotations should be submitted in closed firm head cover with address.
7. The bidder should have valid registration under GST, IT etc.
8. A sum of Rs.10,000/- (Rupees Ten Thousand) only may be deposited in shape of Demand Draft as EMD in favour of Officer-In-Charge, Election, Keonjhar payable at Keonjhar alongwith quotation paper. The amount so deposited will be kept as security deposit of the selected agency and the EMD of others will be refunded.
