

DOCUMENTS IS TO BE FURNISHED

The Sale Tax, Income Tax clearance, GST Regn. Number, E P & M holder certificates, PAN Card, Recent Conclusion of fresh rate contract in respect of store item "Steel Shelving Cabinet (Steel Almirah) conforming to IS: No.3312/1984" issued by the Department of Director of EPM Odisha, if any, Xerox copy of front page pass book of Bank Account of Firm/Agency should be enclosed with the Willingness papers failing which the same will be rejected.

TERMS AND CONDITION

1. The rate of articles inclusive of all taxes as per E P & M rate along with transportation cost to the Anganwadi Centre point should be quoted in the willingness papers.
2. The Articles should be delivered as per E P & M Specification. The detail Specification of the Steel Almirah as per requirement is annexed.
3. The articles will only be accepted if delivered in Good Condition and found matching with the quality as per specification given in the Expression of Interest as confirmed from Post Verification Report.
4. No firm is allowed to supply more than its annual capacity as per E P & M approved list/D.I.C. certificate.
5. The firms may appear at the time of opening of the papers in person or through his/her authorized representative.
6. The authority reserves all the rights to accept or reject any of the expression of interest without assigning any reason thereof.
7. The articles i.e., Steel Almirah to be supplied to the ICDS Anganwadi Centre point is to be **superscribed** with the name of the ICDS Project & Anganwadi Centre with enamel paint. The rate of printing quoted separately.
8. The rate of the article to be supplied to the Anganwadi Centre point should be within the Govt. prescribed rate i.e., **Rs.5000/- inclusive all taxes.**
9. All supply is to be completed within **03(three) months** from the date of awarded of contract.
10. The selected agency is required to deliver the Almirah at AWC point. Contract is to be awarded on the same condition.
11. DSWO will give a list of AWCs to the Agency where the Almirah is to be supplied.
12. An agreement is to be executed by the selected firms for supply of steel almirah.


