TENDER DOCUMENT FOR SUPPLY OF FOOD (CATERING SERVICES) ON ANNUAL RATE CONTRACT

1. Sealed tenders are invited from registered suppliers/agencies/authorized dealers for supply of food (catering services) to office of the CDM & PHO (NHM, Keonjhar) for a period of one year on annual rate contract basis.
2. Interested bidders may obtain details terms and conditions from the website for taking up this assignment. The interested bidder may download the tender document from our website: www.keonjharnic.in
3. The tender will have to be submitted in two parts i.e. **technical bid (Cover-A)** and **price bid (Cover-B)**. The bidders should submit their technical and price bid separately in two envelopes clearly marked as technical bid & price bid and those two envelopes should be put into another outer envelop superscribed as **"Tender for Supply of Miscellaneous Stationary Items on Annual Rate Contract Basis to CDM & PHO (NHM, Keonjhar) to advt. No- dtd.18.02.2019"**.

The last date & time of submission of tender is **25st Feb 2019, 4 PM**. The tender shall be opened on **25st Feb 2019** at **04.30 PM** in the conference hall of DTU, Keonjhar in the presence of tenderers or their authorized representative who may wish to be present. The tender document is to be submitted by post/courier services only.

Terms & conditions

Bidders who **qualify technically** [as per submission of relevant valid documents as asked to be submitted in Technical Bid – Cover A – Part 1, fulfilling all the terms & condition of the tender document], their **Price Bid** (Cover B - Part 2) shall **only** be opened.

1. The firm should have GSTIN.
2. The firm should have PAN
3. Photocopy of Income Tax Return for the year 2017-18.
4. Valid Food License from appropriate authority.

Tender must be accompanied by **Tender document Cost** of **Rs.500/-** (Non refundable) and **EMD of Rs. 2,000/-** in technical bid by way of demand draft, drawn on any Nationalized/ Scheduled Bank in favor of **ZSS(RCH-II), Keonjhar** payable at keonjhar. Tenders not accompanied by tender document

cost & EMD will not be considered. EMD of unsuccessful tenderers will be returned without interest on finalization of bid. EMD of successful tender will be retained & will be refunded on successful completion of the job without interest.

5. The firm will have to submit an **Affidavit** (*On original Stamp Paper of relevant value*) in the technical bid with the following clauses :-
 - a) Our organization has not been blacklisted by any Government Organization
 - b) Our organization does not have any legal suit / criminal case pending against it for violation of VAT/ST/CST Act/GST or any other law.
 - c) The CDM & PHO, Keonjhar will have no liability regarding transportation and serving of food .Our organization agrees to abide by all terms & conditions of tender
 - d) Our organization will quote prices **inclusive** of all taxes.
6. In the technical bid the supplier will also have to submit the photocopies of PAN, GST registration having GSTIN, food license and copy of IT Return copy for the year 2017-18.
7. The supplier selected shall have supply the food in the office of the undersigned against the supply order. The bidder has to make his own arrangement for transportation of food, serving of food and supply of necessary paper plates.
8. This rate to be quoted must inclusive of transportation, serving of foods and paper plates and the rate will be valid for **one year** on an annual rate contract basis.
9. The suppliers shall also ensure that the quality and quantity has to be as per the supply order and approved rate contract.
10. The supply of items shall be made immediately (within a day) after placement of supply order at the Office of the CDM & PHO, Keonjhar and supplier shall submit the bill for payment at the approved rate in respect to the quantity of items supplied.
11. The approved supplier shall have to furnish a performance security of Rs.2,000/- in the shape of demand draft in favour of ZSS(RCH-II), Keonjhar payable at Keonjhar which will be retained till successful completion of the rate contract period. However, the EMD of Rs.2,000/- submitted by the approved bidder at the time of bid submission may be converted to Performance Security and in that case the approved bidder does not have to submit any additional performance security.

12. For any dispute, decision of CDM & PHO shall be final.

13. All legal disputes are subject to the jurisdiction of keonjhar court only.

14. The CDM & PHO, Keonjhar reserves its right to accept or reject any or all tenders or any part thereof without any liability to communicate any reason.
