

2. The Tender must pay non-refundable service charges as mentioned against the above work including GST in shape of demand draft from any nationalized Bank payable at Jhumpura drawn in favour of BDO, Jhumpura or else tender paper will be rejected.
3. Bidders are requested to submit the documents along with the deposit, the requisite non-refundable fees are mentioned Colum 05 in shape of demand draft and prepared on or before last date of sale of Tendirer Paper and submit the same along with the bid keeping in the separate envelop marks cost of Tender documents.
4. The tender paper will be received by **registered post/speed post** only up to 5.00PM till 15.03.2019 sealed tender paper must be accompanied with self attested copies of valid Contractor Licence, GST


Clarence Certificate, Pan Card, No Relation Certificate, Non-refundable service charges. EMD @1% of the amount put to tender in shape of NSC/KVP/POSBA/POTD/Deposit receipt of scheduled bank duly pledged in favour of the BDO, Jhumpura and an affidavit regarding authenticity of the documents produced without which the tender paper is liable for rejection. The tenderer must write in "TENDER PAPER" for the work .....on the top of the envelop containing the tender documents.

5. The tender paper shall be opened by the BDO, Jhumpura/ his authorised officer in presence of the tenderer or their authorised agents on the schedule date and time as mentioned below:
  - A. Date of sale of Tender Paper:- Dt. 01.03.2019 to 14.03.2019 during office hour.
  - B. Last date of receipt of Tender Paper:- Dt. 15.03.2019 till 5.00 PM.
  - C. Date and time of Opening of Tender Paper:-Dt. 16.03.2019 at 11.00AM.
6. Transfer or adjustment EMD of ISD amount with other works will not be entertained.
7. Extension of time beyond the completion of time period of the project on the ground of unavoidable hindrance permitted under OPWD code is only allowed by competent authority.
8. SC/ST individual bidder willing to avail to benefit within 10% of rate quoted by the lowest tenderer for any work, the work to be considered for award to him/her of lowest tendered rate in relaxation in OGFR. (OPWD code) on that effect tenderer must submit affidavit & must furnished the self attested XEROX COPY OF CASTE CERTIFICATE otherwise concession / facilities will not be considered.
9. The engineer bidders (Degree & Diploma) seeking exemption of EMD must submit their original licence at the time of opening of tender papers failing which the tender is liable for rejection.
10. The Authority will not be responsible for any postal delay even if dispatched before due date.
11. The tenderer has to furnish an affidavit in support of authenticity of his tender documents and affidavit regarding not abandoned any work during the last five years.
12. Only the successful Bidder who has quoted less bid price/rates than the estimated cost put to tender shall have to furnish the exact amount of deferential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performace Security in shape of Term Deposit Receipt pledged in favour of the Block Development Officer, Jhumpura within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further proceeding for black listing shall be initiated against bidder.
13. If the rate quoted by the bidder is more than 14.99% less, then the bid will be rejected.
14. The Authority reserves the right to reject any/all tenders without assigning any reason thereof.
