Expression of Interest

For implementation of District Mineral Foundation, WADI plantation project during 2019-20 for supply of different inputs by the facilitating agencies, whole sale dealer and supplier invited to offer their Quotation by 31.05.2019 and opening of Quotation has been made on 03.06.2019 at 11.000 AM in the Office of the Deputy Director of Horticulture, Keonjhar. The price offered by the Agencies were significantly higher than the approved estimate budget for RCC Fencing Posts size 7'0" x 0'4" x 0'4" size with RCC 1:2:4 with 12 mm size cbg chips accompanied with 4 nos. of 6 mm dia longitudinal reinforcement and 4 mm dia rings @ 150 mm c/c. So, the Committee decided to cancel the tender & to re-tender in order finalise the supplier for RCC Fencing Post.

So, the interested Manufactures wholesale dealer and supplier indents to supply are invited to offer their quotation price for supplies of above size RCC Fencing Posts for re-finalization of EOI. The details of quotation call notice is available with the Keonjhar District Website (www.kendujhar.nic.in). The last date of submission of Quotations on or before 5th July 2019 and opening of Quotation for re-tender on 07.07.2019 at 11.00 AM in the Office of the DDH, Keonjhar.

The Supplier / Agencies who had participated in last tender process may participate again and need not to submit the processing fee for Rs. 500/- as they had submitted same in last tender.

Quotation Call Notice

Rates of the RCC Fencing Posts size 7'0" x 0'4" x 0'4" size with RCC 1:2:4 with 12 mm size cbg chips accompanied with 4 nos. of 6 mm dia longitudinal reinforcement and 4 mm dia rings @ 150 mm c/c. quotations are invited in sealed covers from manufacturers, whole sale dealers and intending suppliers for supply with following terms and conditions: -

- i) The supply rate should include cost of transportation and delivery at Keonjhar.
- ii) The intending bidders must have enclosed valid ITC Certificate, GST clearance notified and copy of valid GST Number.
- iii) The successful intending bidder must deposit 5 % of the total value of supply as EMD in shape of Bank draft in favour of Deputy Director of Horticulture, Keonjhar within 3 days. It shall be refunded to the supplier after successful completion of the delivery of the items and on conformation of the quality within three months or it will be rejected for untimely delivery and quality on pro-rate basis.
- iv) The intending bidders must submit Rs. 500 /- as processing fees (non-refundable) in shape of demand draft payable to Deputy Director of Horticulture, Keonjhar payable at any Bank at Keonjhar.
- v) The payment will be made by the DMF, Keonjhar through the indenting agencies after supply of materials.
- vi) The Quotationer intending to participate may submit the sealed cover by post / courier service. The last date of the receipt of sealed cover in the Office of the Deputy Director of Horticulture, Keonjhar on or before 05.07.2019.
- vii) The sealed covers shall be opened in presence of members of purchase Committee and the Quotationers or their authorised representative on 07.07.2019 at 11.00 AM in the Office of the Deputy Director of Horticulture, Keonjhar. The decision of the committee shall be final.
