

2. The Quotationers should quote the rate of Ahuja Mike Sets with accessories / Vyasasana etc. including all Taxes and Transporting charges with un-loading till delivery at District Culture Office, Collectorate, Keonjhar. The Quotationers would be selected/ finalized by the Tender Committee.
3. The Tender paper should be filed in properly by the Quotationers without correction/overwriting. The rate quoted by the tender should be final and the Quotationers should not be allowed to change anything under any circumstances. The Tender paper should be completed in all respects. Incomplete tender paper is liable to be rejected.
4. The Quotationers should produce the Photocopy of the following documents/ papers. If authority desires to know the genuineness of the documents/ papers those should be produced in original for confirmation. The Quotationers should have been registered under Goods & Services Tax Act. Up to date GST Return obtained from the competent authority should be attached to the Tender Form. The Quotationers should possess up to date Income Tax Return & PAN Card and enclosed the copies of the same with the Tender Form.
5. The Successful Quotationer should deposit the paper cost of Rs. 10,000/- (Rupees Ten thousand) only in case of Mike Set during time of placement of order which is non refundable.
6. Successful Quotationers / Supplier should maintain the brand, quality & ok report with sound testing of the Mike Set.
