





Terms & conditions

The PIAs intending for conduct of SDT/ PLET shall fulfil the following terms and conditions.

1. The PIAs other than Govt. institutions should be empanelled by OSFDC Ltd/OSDA. They have to submit/enclose relevant MoUs/ documents in support of empanelment with OSFDC Ltd/OSDA.
2. The PIAs should have at least three year proven experience in under taking SDT & PLET Training.
3. The PIA have to submit/enclose latest copy of renewal letter & last three years placement records
4. The PIAs have to submit/enclose audited financial statement of last three years relating to conduct of SDT & PLET Training.
5. The PIAs should submit the services tax/TDS clearance certificate and income tax return copy for last three years.
6. The training is purely residential in nature & the PIAs are required to mention clearly the location of training centres, name of the trades etc.
7. The PIAs should maintain due diligence as per Standard Operating Procedure (SOP)/Latest Guidelines of OSFDC Ltd. and OSDA.
8. **No franchise and engagement of 3rd parties by the PIA will be allowed.**
9. The authority reserves all the rights to cancel or modify the EOI without assigning any reason thereof.
