The sale and receipt of the Bid document shall start from 01.10.2019 during office hours and close on Dt. 21.10.2019 at 2.00P.M. in the office of the Block Development Officer, Joda Dist-Keonjhar. The bids will be opened by the Tender committee of Panchayat Samiti, Joda I.e. at 03.00 P.M. on dated 21.10.2019 in presence of the bidders or their authorized representatives who wish to attend. If the office happens to be closed on the date of opening, the bid will be opened on the next working day at the same time and venue.

Further details terms & conditions & other eligibility criteria can be obtained from the Panchayat Samiti, Joda during the office hours up to 21.10.2019 at 02.00 P.M. or from District website www.kendujhar.nic.in. The sealed bid document can be sent by Registered Post/Speed Post only.

TERMS & CONDITIONS

1. Cost of tender: Tender documents for the individual works may be obtained from the Block office Joda as per annexure on payment towards cost of tender paper in shape of Bank draft drawn in any nationalized bank in favour of BDO, Joda payable in **Bank of India, Joda** of Keonjhar District.
2. Sale of tender paper: Tender documents will be sold from 01.10.2019 to 21.10.2019 from 10.00A.M. to 05.00P.M.(working days only) except 21.10.2019(10.00 A.M to 02.00)P.M.
3. Date of receipt of tender paper: Tender paper in complete in all respect will be received from 01.10.2019 to 21.10.2019 from 10.00A.M. to 05.00P.M working days only but on 21.10.2019 (up to 02.00 PM)in the office of the Block Development Officer, Joda through REGISTERED POST/SPEED POST only. The name of the project for which tender paper is filled should be written in CAPITAL LETTERS on the cover in which all the required papers are kept and sealed .
4. Tender received by post after the stipulated date and time mentioned above will not be considered .
5. Date of opening of tender paper: The tender shall be opened on 21.10.2019 at 03.00P.M. in the office of the Block Development Officer, Joda in presence of the Bidders or their authorized representatives having written authorization for the purpose along with all relevant original documents.
6. Earnest money deposit:-01% (one percent) of the Bid value in shape of post office term deposit/short term deposit/N.S.C./K.V.P./Deposit receipts of any nationalized Bank duly pledged in favour of Block Development officer, Joda .
7. The following documents should be furnished with the tender paper failing which the tender is liable for rejection.
 - a) Earnest money deposit pledge in favour of BDO, Joda.
 - b) Self Attested copy of valid contractor Registration Certificate.
 - c) Self Attested copy of valid PAN card/VAT clearance certificates.
 - d) Xerox copy of Bank Draft towards cost of tender paper.
 - e) The bidders have to produce an original affidavit in support of the authenticity of documents including EMD etc, attached with the tender paper.
 - f) The Engineer Contractors desirous of availing exemption of EMD should submit an original affidavit as regards the fact of availing award of work without submission of EMD/ISD during the current financial year as per Govt. guidelines, otherwise their tender paper will be liable for rejection.
 - g) As per Govt. guidelines the SC/ST Contractors desirous of availing preference should submit an original affidavit in support of caste certificate and self attested copy of caste certificate, otherwise their tender paper will be liable for rejection.
 - h) Joint venture consortium agreements are not allowed to participate in tender.

- i) A critical analysis and working procedure should be submitted along with bid paper if the quoted amount is less than the estimate cost by more than 10% for examination by the committee.
8. Additional performance security deposit: As per Office Memorandum No. 14299/W , dated: 03/10/2017 of Works Deptt. Govt. of Odisha, the amendment made to Para 3.5.5(v) of OPWD Code, Vol-I with following modification.

“Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, only the successful bidder who has quoted less bid price/rats than the estimated cost put to tender shall have to furnish the exact amount of differential cost I,e. estimated cost put to tender minus the quoted amount as Additional Performance Security(APS) in shape of Demand Draft/ Term Deposit receipt pledged in favour of the Block Development Officer, Joda within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder”.

9. Shortfall of any required document(s), draft(s) and EMD, tender paper is liable for rejection.
10. If the date of sale, receipt and opening of the tender as specified above happens to be holiday(s), then the process of the sale, receipt and opening whatsoever will be shifted to immediate next date of tender paper opening may be postponed as per the convenience of the authority by intimating all the concerned tenders through notice affixing to notice board at Panchayat Samiti, Joda only.
11. The details of successful bidders against each work will be displayed in the notice board. The successful bidders will collect the letter of acceptance from the office of the undersigned within 07 days from the date of declaration of list of successful bidders on the notice board in order to avoid postal delay for early execution of the work. No further claim will be entertained for non receipt of acceptance letter.
12. The EMD amount is to be forfeited if the tender backs out from the offer acceptance of tender by the competent authority.
13. The authority reserves the right to reject any or all the tenders without assigning any reason thereof.
14. The successful bidder shall sign an agreement with BDO, Joda in the non-judicial paper of worth Rs.200/- (Rupees Two hundred) only for executing the work.
15. The detail plan & estimate may be checked and the work shall be executed or done by the successful bidder as per the plan & estimate of this office.




