This office will not entertain any tender after the due date/time fixed for at any circumstances. The contract will be valid for a period of One year.

The undersigned reserves the right to reject any or whole tender without assignment any reason thereof.

Terms & Conditions:-

- 1) The organization should be a registered under DIC
- 2) The organization should have PAN & up to date GST clearance certificate
- 3) Tender must be accompanied by (EMD) of **Rs. 12,000/- (Twelve thousand only)** by way of Demand Draft, drawn on any Nationalized Bank in favour of **SUNETRA KEONJHAR**. Tenders not accompanied by EMD will not be considered. Security of unsuccessful tenders will be returned without interest on finalization of bid. EMD of successful tender will be retained & will be refunded on successful completion of the job without interest. The said deposit must be submitted along with Tech. Bid.

Deduction shall be made till 4% of purchase order rate. If the bidder still fails to supply his order stand cancelled.
