Terms and Conditions

The PIAs intending for conduct of SDT/PLET shall fulfill the following terms and conditions.

01. The PIAs other than govt. institutions should be empanelled by OSDA. They have to submit/ enclose relevant MoUs/ documents in support of empanelment with OSDA.
02. The PIAs should have at least three year proven experience in under taking SDT/PLET training.
03. The PIA have to submit/ enclose latest copy of renewal letter & last three years placement records.
04. The PIAs have to submit/ enclose audited financial statement of last three years relating to conduct of SDT & PLET training.
05. The PIAs should submit the services tax/GST/TDS clearance certificate and income tax return copy for last three years.
06. The training is purely residential in nature & the PIAs are required to mention clearly the location of training centers, name of the trades etc.
07. The PIAs should maintain due diligence as per Standard Operation Procedure(SOP)/ Latest Guidelines of OSDA.
08. No franchise and engagement of 3rd parties by the PIA will be allowed.
09. The authority reserves all the rights to cancel or modify the EOI without assigning any reason thereof.


