02. The Driver of the vehicle must have a valid Driving license for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.

03. Driver should be well behaved , gentle and obedient in nature.



ANNEXURE-II

TERMS AND CONDITION OF HIRING VEHICLES

The following terms and conditions must be fulfilled by the successful bidders for providing a vehicle on hire on monthly rent basis.

01. The hired vehicle, during the period of contract, shall have all necessary valid M.V documents such as:- Valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid contract carriage permit, proof of up to date tax payment, GST Registration, Proof of pollution certificate etc and D.L of driver available all times. The office hiring the vehicle shall not be responsible for any damage /loss caused to hired vehicle or loss of life / injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall not be responsible for all such litigation.

2. The hire charges to be paid for monthly basis is final but does not include the cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubrication oil of engine, Gear Box and different coolant, Tyres and Tubes, Battery etc will be borne by the bidder.

03. It shall be the responsibility of the bidder to provide a good driver and salary of the driver shall be borne by the owner.

04. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same, or better model shall be provided by the owner of the vehicle/bidder.

05. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.

06. The vehicles shall report for duty for minimum 25 days in a month. The vehicle shall report for duty at 8.00 A.M after duty, the vehicle will be parked at owner's risk.

07. In case of emergency, the driver will have to report for duty as per requirement of the hirer. No extra payment shall be demand.

08. Monthly hire charges and reimbursement towards cost of diesel (as per actual) and lubricants (as per Govt norms) of selected bidder will be paid in every succeeding month, as per as possible within 15 days of the submission of bills by the service provider and no advance payment will be made.

09. The vehicle shall not be more than 3 years of old from the initial registration and also in good running condition the period of contact.

10. If the services are found to be unsatisfactory, the client shall given one month notice and terminate the agreement.

11. In case of the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon his to grant one month notice before withdrawal of service and termination of agreement.

12. If the bidder violate any of the terms of contract, Government shall forfeit the entire amount of security deposit.

13. The successful bidder has be enter into an agreement with the undersigned for providing the vehicle with certain agreeable terms and conditions.
