3. ELIGIBILITY CRITERIA:

- (I) Revenue Inspectors/Amins who have retired from Government service on attaining the age of superannuation and below the age of sixty five years having good service records and are physically fit shall be eligible to be considered for reemployment.
- (II) Revenue Inspectors/Amins against whom departmental proceedings or criminal cases are contemplated/pending or who have been penalized for misconduct during the period of preceding five years will not be eligible for consideration.

4. SELECTION PROCESS:

- (I) Selection of persons will be made through open advertisement.
- (II) There shall be a Selection Committee as may be decided by the appointing authority for the post/posts required to be filled up by re-employment.

5. TENURE, TERMS AND CONDITIONS:

- (I) The re-employment shall be made for a period of 01(One) year or till regular recruitment process for filling up these vacancies is completed whichever is earlier.
- (II) Re-employed employees shall be governed by the provisions of Odisha Government Servants' Conduct Rules, 1957 and shall be liable to be proceeded

against their misconduct, omissions and commissions as per the provisions under the Odisha Provision Rules, 1992.

- (III) Re-employed Revenue Inspectors and Amins will be entitled to pay Rs.19,000/-p.m. and Rs.13,000/-p.m. respectively as consolidated remuneration.
- (IV) The re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed employee by giving one month notice. On the contrary if any re-employed employee desires to resign he shall do so by giving one month's written notice to the competent authority.
