Sealed quotations are invited from interested reputed printers or private individuals for printing/supplying of office materials (Community Growth Chart) for ICDS Project, Patna which shall conform to the following terms and conditions.

1. The specification of the chart/Flex is 5"x4"
2. The chart is pink for girls and Blue for boys
3. The maximum price for printing of one chart is Rs.1000/-(Rupees one thousand) only. But the lowest Quotationer will be selected for printing/supplying of flex/Chart.
4. A sum of Rs.4,000/-(Rupees Four thousand)only shall be deposited by the intending bidders in shape of Account payee Bank draft drawn in favour of CDPO, Patna as security money and will be refunded after supplying of printing materials. In case of the bidder not selected for printing/supplying the printing materials the security money will be refunded after completion of tender process.
5. The rate of printing charges for chart should be quoted separately in the general bid information.
6. The quotation should be submitted in the address child Development Project Officer, Patna super scribing "QUOTATION FOR PRINTING OF COMMUNITY GROWTH CHART" on the top of the envelope and dropped in the tender box placed in front of Child Development Project Officer, Patna.
7. The Quotation completed in all respect should reach the undersigned on or before 20.11.2020 at 3.00 PM and shall be opened in the office chamber of CDPO Patna on 21.11.2020 by 3.30pm. in presence of the committee members.
- 8- The quotation will have to purchase application form by paying Rs.100/- during office hour (except Govt. holidays).
9. The application form of quotation /tender containing general bid information and term and condition etc. will be available in the office of the ICDS Project, Patna
10. The quotation should have a valid GST number.
