- 13. Cost of tender paper:** The tender specification can be obtained from the office of the Block Development Officer, Jhumpura on Payment towards the cost of Tender papers as mentioned above(non refundable) in shape of bank draft or demand draft only(no other modes will be entertained) drawn in favour of Block Development Officer, Jhumpura in any nationalized bank having its branch at Jhumpura on any working day from **08.03.2021 to 22.03.2021** for the above work.
- 14. Sale of Tender Papers:** The tender documents will be sold from **08.03.2021 to 22.03.2021** at Block office, Jhumpura between 10AM to 5PM on working days only.
- 15. Date of receipt and mode of submission of tender paper:** The tenderers have to submit the sealed tender papers in complete shape through registered post/ speed post only by directly sending in to the BDO, Jhumpura in his official postal address. The last date of receipt of tender paper is **22.03.2021** up to 5PM. The undersigned will not be responsible for postal delay if any or non receipt of the papers in time. The Tenders must super scribe the name of the work / Project on the sealed envelope.
- 16. Date of opening of Tender Papers:** The tender paper shall be opened on **23.03.2021** at 11.00AM in the presence of tenderers or their authorized representative having written authorization for the purpose and the tender committee.
- 17. Earnest money deposit:** 1% (one percent) of the bid value in shape of post office, term deposit/ short term deposit/ N.S.C/ K.V.P/deposit receipt of any Nationalised bank duly pledged in favour of Block Development officer , Jhumpura. The tender papers with out required amount of E.M.D. will not be considered and transfer or adjust of EMD is not inadmissible.

18. **Documents to be attached:** The following documents to be furnished with the tender papers failing which the tender will be liable to rejection.
- i) EMD pledged in favour of the Block development officer, Jhumpura.
 - ii) Self attested copy of contractor registration certificate.
 - iii) Self attested copy of PAN card and certificate of GSTIN.
 - iv) Original Money receipt granted by BDO, Jhumpura towards cost of tender paper.
 - v) Attested copy of cast certificate issued by competent authority in case of SC, ST contractors desirous of availing preference.
 - vi) The bidders have to Produce an original affidavit in support of authenticity of documents including EMD, etc attached with the tender papers.
 - vii) Affidavit as regards the facts of availing award work without submission of EMD/ ISD/ during the current financial year in case of Engineer Contractors desirous of availing exemptions of EMD otherwise the ir tender papers will be liable for rejection.
 - viii) Joint venture consortium agreements are not allowed to participate in tender.
19. Shortfall of any required documents and EMD, TENDER paper is liable for rejection.
20. **Additional performance security deposit:**
The affidavit in lieu of APS will be submitted by successful bidder for the cost of less coated in percentage of the amount put to tender before signing of the agreement of the contract.(vide works dept letter no.- 13286 date -07.09.2017 Govt of Odisha works department)
21. **Forfeiture:** The EMD amount will be forfeited , if the tenderer backs out from the acceptance of tender, by the competent authority.
 22. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.
 23. The block development Officer, Jhumpura reserve the right to reject any or all the tenders without assigning any reasons thereof other details can be seen in the bidding documents.
 24. If the rate quoted by the bidder is more or less than (14.99% less) of the tendered amount, then such a bid shall be rejected or the tender shall be finalized basing on the merits of rest bids. But if more than one bid is quoted at 14.99%(Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tendered accepting authorities will finalize the tender through a transparent lottery system where all the bidders/ authorized representatives, the concerned BDO and tender committee will remain present.
