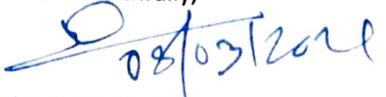

Post/Courier and which will be opened on same day on 04.30 pm at DTU Conference Hall NHM, Keonjhar. This office will not entertain any tender after the due date/time fixed for at any circumstances. The contract valid for a period of One year.

The undersigned reserves the right to reject any or whole tender without assignment any reason thereof.

Terms & Conditions:-

- 1) The organization should be a registered under DIC.
- 2) The organization should have PAN & up to date GST clearance certificate
- 3) Tender must be accompanied by (EMD) of Rs. 10,000/- (**Ten thousand only**) by way of Demand Draft, drawn on any Nationalized Bank in favour of ZSS (NPCDCS) payable at **Keonjhar**.
