- 1) The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, Fitness Certificate, valid Contract Carriage Permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
- 2) The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
- 3) The Driver should be well behaved, gently and obedient in nature.
- 4) A sum of **Rs.5000.00** shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the Special Land Acquisition Officer and Competent Authority, NH6(49) Project, Keonjhar and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
