The earlier Advertisement published vide No.697/Welfare/ Dated.27.02.2020 for engagement of 12 nos. of Contractual Tribal Language Teachers in ST&SC Development Department of Keonjhar District is hereby cancelled due to modification of guidelines for engagement of Tribal Language Teachers by the Govt. in ST&SC Development Department. The applicants, who have applied earlier as per the said advertisement, may again apply afresh for the post as per the present Advertisement.

## 1. General eligibility:-

- (a) He /She must be a citizen of India.
- (b) He/ She must not have more than one spouse living.
- (c) He/ She must be a permanent resident of Keonjhar District.
- (d) He/ She must bear a good moral character.

## 2. Qualification:-

The candidates having minimum qualification of +2 Science/ Arts/ Commerce or its equivalent examination declared by the appropriate authority with desirable training qualification and the candidate must have proficiency in the Language which is operational in schools under Multi Lingual Education (MLE) programme. The candidate must have Odia as mother tongue up to Class-VII.

#### 3. Age:-

The candidate shall not be below 18 years and above 40 years of age as on 01.07.2021.

#### 4. Reservation:-

Reservation of vacancies for SC/ST/SEBC/ Sportsmen/ Physically Handicapped / Exservice men / Women shall be provided under the Odisha Reservation of vacancies in posts and services (for Scheduled Castes/ Scheduled Tribes) Act, 1975 and the rules framed there under and under such other rules and orders issued by the Government from time to time.

Provided further that if any other reserve category except ST are not available then the posts shall be filled up by the ST category of the said community.

### 5. Selection Committee:-

The Selection Committee will be comprised under Chairmanship of the Collector, Keonjhar, District Welfare Officer, Keonjhar and Headmasters / Headmistress of the concerned Schools.

## 6. Selection Procedure:-

The Selection shall be made only on merit basis i.e. There shall be a "Proficiency Test" for the concerned Tribal Language to be conducted at the District Headquarter. There will be 75:25 weightage given to each candidate for the concerned language proficiency (Marks obtained in the Proficiency Test) and percentage of marks secured by the candidates in the qualification examination (HSC).



### 7. Service condition:-

- (i) The service of Tribal Language / MLE Teachers is purely temporary and contractual in nature and the service is terminable without notice by the competent authority without assigning any reason thereof.
- (ii) A contract / agreement of engagement shall be executed between the Collector, Keonjhar on behalf of the State Government and by the contract person to be signed on Stamp Paper.
- (iii) The contract will be valid up to the end of February of the Financial Year from the date of engagement and can be terminated earlier if he/she violates the condition of contract or is found unsuitable by the Authority without assigning any reason.
- (iv) Renewal of the Contract Engagement can be considered only if the continuance of the post is extended with concurrence of the Finance Deptt. and subject to satisfactory performance of the candidates to be evaluated by the appropriate authority.
- (v) The Tribal Language / MLE Teachers must maintain regularity and punctuality in attending school. They must impart teaching in their respective languages along with other languages. They must ensure completion of entire curriculum within the specified time. They must assess the learning ability of each child and accordingly supplement additional instruction if any as required. They must ensure minimum level of learning for the students as prescribed by the competent authority. They must ensure at least 90% attendance of the children in respective schools in all classes. They shall motivate the parents/ guardians of the village in which school is situated for enrolment of children within the age group of 6 14 years. They shall perform all such other duties as assigned to them by the competent authority as and when required.
- (vi) The contract person shall be entitled to avail leave under the provisions of the Odisha Leave Rules, 1966 at par with regular employees of Govt. of Odisha.

#### 8. Remuneration:-

The monthly consolidated remuneration of the persons to be engaged in the contractual post of Tribal Language Teacher is **Rs.9,250/- (Rupees Nine Thousand Two Hundred Fifty) only**. Every year their remuneration shall be hiked as per G.A. Deptt. Notification No.19574/Dtd.12.09.2017.

#### 9. Training:-

The training of the teachers in the MLE transactional module shall be undertaken by the ST&SC Development Department. The course material shall be developed by the Govt. in ST&SC Development Deptt., Odisha.

## 10. Mode of application:-

Application complete in all respect along with the relevant documents should be sent in a closed cover addressed to the **District Welfare Officer**, **Keonjhar**, **PIN-758001** by **Regd.
