
Sealed tenders from the intending parties are invited for taking of Pisciculture in Tank No-I, II of Gohira Farm, Tank No-I, II of Sangam Farm & Tank No. I of Keonjhargarh Farm for the year 2022 to 2025 on lease basis for three years i.e 01.07.2022 to 30.06.2025 The prescribed form for tender can be obtained from the office of the undersigned during office hour in working days from Dt. to Dt. 11.05.2022. The intending parties are required to deposit earnest/ secured money pond wise as per their intended bid in the office of the undersigned. The sealed tender paper along with copy of the money receipt of the form for the purpose & copy of photo ID card will be received by this office by Dt.25.05.2022, upto 1 PM by post or person. The earnest money deposit will be treated as Security Money in case of successful bidder which will be refunded to him after completion of his leasing period. The earnest money of other unsuccessful bidders will be refunded to them immediately after finalization of tender paper. The successful bidder is required to abide by certain term and conditions of the farm for taking up pisciculture in Govt. Agril. Farm Tanks. The tender papers will be opened on Dt.26.05.2022 at 11 AM in the office of the undersigned in the presence of the Tender Committee members/bidders or their authorized representatives.

**TERMS & CONDITION**

1. The successful bidder is liable to pay 50% of the bid amount in the office of the undersigned for taking up pisciculture in the farm tank & issue of orders accordingly. The balance bid amount should be deposited same day of receipt of the final order.
2. The concerned farm in-charge Officer have the right to use the tank water for irrigation purpose whenever necessary
3. The bidders have no right to cause any damage to the farm crops/orchards or any other property for the purpose of taking up pisciculture in dept. Farm tank.
4. The successful bidders have no right to pollute the tank water in any way for the purpose of pisciculture.
5. The successful bidder shall engage their labours for taking up pisciculture only after taking due permission from Farm In-charge Officer.
- 6 The successful bidder shall clean the tank if necessary at his own cost without any damage to tank bund obtaining due permission from the Farm in-charge Officer.
7. Watch and ward problem of the tanks during the period of pisciculture is the entire responsibility of the bidder.
8. The successful bidder will have to sign an arrangement to this effect after the bid is over.
9. The bidding amount will be increased by 10% for the succeeding year.
