I. Qualifications

The District Resource Person (DRP) should have the following qualifications:

- a. Diploma/ degree in Food Technology / Food Engineering from reputed State / National / International Universities / Institute.
- b. 3-5 years experience in providing consultancy services to food processing industries for technology up-gradation, new product development, quality assurance, food safety management etc.
- c. In absence of candidates in the above two criteria, persons with experience in food processing industries, banking, DPR preparing and training will be considered.

II. ROLES AND RESPONSIBILITIES:
