OFFICE ORDER

No. 960 /RTA/Dated 20/03 /2020

In view of existing disaster situation for the human being all over the world due to spread of Novel Corona Virus (Covid-19) & in exercise of the powers conferred under Rule 63 of the Orissa Motor Vehicle Rules, 1993, I, Sri Ashish Thakare, IAS, Collector and District Magistrate, Keonjhar do hereby make the following restrictions in the interest of general public health. It may be noted that these restrictions are purely temporary in nature and will be reviewed on a dynamic basic and suitable modification shall be exercised depending on the situation.

All public transports including taxis and auto rickshaws on hire inside the city limits of all the Urban Local Bodies of Keonjhar District i.e. Keonjhar Municipal Corporation, Barbil Municipality, Joda Municipality, Anandapur Municipality and Champua NAC will be regulated on alternate days i.e. odd vehicle registration numbers in odd dates and even vehicle registration numbers in even dates and these restrictions will remain in force until further orders. These restrictions will come into force with immediate effect.
