**SECOND CORRIGENDUM NOTICE TO
TENDER CALL NOTICE NO. 01 OF 2021-22 OF BDO ,CHAMPUA**

1. In Sl. No. 42 of Terms & Conditions of Bid Document to be read as " **Additional Performance Security Deposit** : The APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract.(Vide Works Department Letter No.-14459/W Date-20.09.2018, Govt. of Odisha, Works Department.) As per office Memorandum No 4559 Dated 05.04.2021 of works Deptt. Govt. of Odisha modification to APS will be followed as detailed below:-

Sl. No	Range of Difference between the estimated cost put to tender and Bid Amount	Additional Performance Security to be deposited by the successful Bidder
1	Below 5%	No Additional Performance Security
2	From 5% and above and below 10%	50% of (Difference between estimated cost put to tender and Bid Amount)
3	From 10% and above	150% of (Difference between estimated cost put to tender and Bid Amount)

In stead of " Additional Performance Security shall be obtained from the bidder when the bid amount is less than estimated cost put to tender. In such an event, **only the successful bidder who has quoted less bid price/rates** than the estimated cost put to tender shall have to furnish the exact amount of differential cost i.e. estimated cost put to tender minus the quoted amount as Additional Performance Security (APS) in shape of Demand Draft/Term Deposit Receipt pledged in favour of the Block Development Officer, Champua within seven days, otherwise the bid shall be cancelled and the security deposit shall be forfeited. Further, proceeding for blacklisting shall be initiated against bidder. All other details remain unchanged.
