No other mode of receipt of quotation will be entertained. The envelope containing quotation paper should be superscribed by "QUOTATION FOR AUCTION OF VEHICLE IN DPMU, KEONJHAR".

The quotation will be opened on 20.05.2021 at 10.00 AM in the office chamber of the undersigned. Quotationers or their authorised representatives may remain present at the time of opening of the quotations. The competent authority has fixed the off set price of the vehicle at ₹ 36, 300/- (Rupees Thirty-six thousand Three hundred) only. The quoted price should not be less than the off-set price so fixed. The highest quotationer / bidder will deposit 50% of the total bid amount on the same date through Bank draft. If he fails to deposit the balance amount within 7 (seven) days from the date of opening of quotation, the Earnest money will be forfeited and the next higher bidder will be allowed to buy the vehicle. The earnest money of the other bidders except the successful bidder will be refunded within 15 days from the opening of the quotation.


