2. The tenderer must pay non-refundable service charges as mentioned against col. 05 the above work including GST in shape of bank draft from any nationalized Bank payable to Ghasipura drawn in favour of BDO, Ghasipura or else the tender paper will be rejected.
3. Bidders are requested to submit the bid document along with the deposit the requisite non-refundable fees as mentioned in column-05 in shape of demand draft

and prepared on or before last date of sale of tender paper and submit the same along with the bid keeping in a separate envelope marks cost of tender documents.

4. **Date of receipt and Mode of submission of Tender papers:** - The Tender have to submit the sealed Tender papers in complete shape through **Registered Post/Speed Post only**, by directly sending it to the BDO, Ghasipura in his official postal address. The last date of receipt of Tender paper is **12.05.2021** up to 1.00 P.M. The undersigned will not be responsible for postal delay, if any or non receipt of the papers in time. **The Tenders must super scribe the name of the work/ Project on the sealed envelope.**
5. **Date of opening of Tender Paper:** - The Tender paper shall be opened on **13.05.2021** at **8.00 A.M** in the presence of the Tenderers or their authorized representative having written authorization for the purpose and the Tender Committee.
6. **Documents to be attached:** - The following documents should be furnished with the tender papers failing which the tender will be liable to rejection.
  - a) **An Affidavit regarding "Bid Security Declaration"** instead of EMD.
  - b) Self attested copy of contractor Registration Certification.
  - c) Self attested copy of PAN card / Certificate of GSTIN.(Up-to-date)
  - d) Self attested copy of Cast Certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
  - e) The bidders have to produce an Original affidavit in support of the authenticity of documents attached with the tender papers.
  - f) Joint venture consortium agreements are not allowed to participate in tender.
  - g) Shortfall of any required document(s) and Tender paper is liable for rejection.
7. **Additional Performance Security Deposit:** - The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (vide Works Department Letter No.14459/W. dtd. 20.09.2018, Govt. of Odisha Works Department.)As per office Memorandum No.4559 dt.05.04.2021 of Works Deptt.
