2. The Tender should be addressed to the District Culture Officer, Collectorate, Keonjhar ,At/Po/District- Keonjhar,PIN-758001 & super scribing "Tender for supply of Ahuja Mike Sets with accessories / Vyasasanans for the District Culture Office, Keonjhar".
3. The committee shall not be responsible for any postal delay or missing of Tender papers. The incomplete Tender received after the scheduled date and time shall not be accepted and liable to be rejected.
4. The Quotationer should clearly quote the rate of Ahuja Mike Sets with accessories / Vyasasanans etc. including all Taxes and Transporting charges with un-loading till delivery at District Culture Office, Collectorate, Keonjhar. The Quotationer would be selected/ finalized by the Tender Committee.
5. The Tender papers should be filed in properly by the Quotationer without correction/overwriting. The rate quoted by the tender should be final and the Quotationer should not be allowed to change anything under any circumstances. The Tender paper should be complete in all respects. Incomplete tender paper is liable for rejection.
