nationalized Bank payable at Swampatna drawn in favour of BDO, Patna or else the tender paper will be rejected.

Bidders are requested to submit the bid document along with the deposit of requisite non-refundable fees as mentioned in column-04 in shape of demand draft and prepared on or before last date of sale of tender paper and submit the same along with the bid keeping in a separate envelope marks cost of tender documents.
4. The tender paper will be received by **registered post / speed post** only up to 5.00 PM till dt. 02.07.2021 in working day. 




