Sealed quotations/tenders are invited from interests reputed Travel Agencies/Tour Operators or private individuals for providing **01** no of Non AC/ AC Diesel driven vehicles having sitting capacity not more than eight including driver, which shall conform to the terms and conditions (Annexure-I) for **Mobility Support to Lady Supervisors for Field Monitoring and Facilitate visit to Hard to Reach area under OMBADC** for ICDS Project, Ghasipura on monthly rent basis.

1. The vehicle must be in Road Worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid Registration Certificate, Insurance Certificate, fitness Certificate, Valid contract, Carriage Permit, Proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The Driver of the vehicle must have a valid Driving License for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
3. The Driver should be well behaved, gentle and obedient in nature.
4. A sum of Rs.5000/- shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of the CDPO, Ghasipura and submitted along with the tender as security deposit. After completion of tender process, the amount will be refunded to unsuccessful bidders.
5. The Maximum hire charges of the vehicle will not exceed of Rs.16000/- (Rupees Sixteen thousand) Only per Month. So the monthly rate of hire charge will be quoted separately in the general bid information.
6. The Vehicle must achieve a fuel efficiency of 10 Kms per liter.
7. The details of the make and year of manufacture of the vehicle registration no., mileage (Kms covered per liter) and name of the Driver with Driving License No. and period of validity should be specifically provided in the general bid information to be furnished with the Quotation / Tender (Annexure-II).

8. The Quotation completed in all respect should reach the undersigned on or before **14.07.2021** by **05.00 P.M** and shall be opened on **15.07.2021** at **12.00 PM** in the office chamber of Sub-Collector, Anandapur in presences of the bidders or their authorized representatives.

9. The application form of quotation / tender containing General Bid Information & terms and conditions for Hiring of vehicles etc. will be available with CDPO, Ghasipura on payment of Rs. 100/- from 30.06.2021 to 14.07.2021.

Annexure-I

TERMS & CONDITIONS FOR HIRING OF VEHICLES

The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as:- valid Registration Certificate, Insurance Certificate, fitness Certificate, Valid contract, Carriage Permit, Proof of up to date tax payment etc.& D.L. of the driver available all the times . The Department / Office hiring the vehicle shall not be responsible for any damage/ loss caused to hired vehicles or loss of life/ injury made to any manner what so ever .The hirer shall be responsible for all such litigation.
2. The hire charges to be paid for monthly basis is final but does not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the bidder.
4. In case of breakdown for reasons whatever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle/bidder.
5. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other source.
6. The vehicles shall report for duty for minimum of 20 days in a month and the vehicle will be parked at owner's risk.
7. In case of emergency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per Govt. norms) of selected bidder with be paid in every succeeding month, as per as possible within fifteen days of the submission of bills by the service provided and no advance payment will be made.
9. The vehicle shall not be more than 3 years old from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give one month notice and termination the agreement.
11. In case the service, provider intends to withdraw the services of his vehicle and terminate the agreement, it shall be mandatory upon him to grant one month notice before such withdrawal of service and termination of agreement
12. If the bidder violates any of the terms of contract, government shall forfeit the entire amount f security of deposit.
