Bids shall be received by this Agency up to 5.00 PM on date 28-07-2021 through Registered Post/ Speed Post only. The authority will not be held responsible for any Postal delay in delivering of the Bid documents or non-receipt of the same. The Bidders must super scribe the SI No of the project and Name of the work on the sealed envelope.
- The Bid will be opened on Dt 29-07-2021 at 11.00 A.M. in the office of the undersigned in the presence of the members of the District Level Tender/ Purchase Committee and the bidders or their authorised representative. If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue.
- Documents to be attached:-** The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
 - An Affidavit regarding "Bid Security Declaration" should be furnished clearly as per latest circular No-5984 / W / Dt-27-04-2021 of Works Deptt. Govt of Odisha so as to avail exemption of EMD.
 - Self attested copy of Contractor registration certificate
 - Self attested copy of valid GSTIN clearance certificate and PAN card
 - Self attested copy of Caste Certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
 - Bidders shall submit original affidavit regarding authenticity of their documents attached with the tender papers.
 - As per Codal Provision works more than Rs 50.00 lakhs should be in Double cover mode i.e. Cover-I contains (Technical Bid) Cover-II contains (Financial Bid) to be fill up separately indicating therein as "Cover-I and Cover-II" respectively and finally put together in one Cover. After due scrutiny the Cover-II will be opened.
 - For SI No-84, 88 and 94 Work experience certificate last 03 years to be produce (minimum upto Rs 60.00 lakhs per year)Those bidders have no experience certificate which the tender will be rejected.
- Checklist is to be duly filled in.
- Engineer Contractors desirous to avail the facility of exemption of E.M.D. is required to submit an affidavit to the effect that he has not yet availed the facility for more than two works during the current financial year. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.

- Additional performance Security Deposite:**
The affidavit in lieu of APS will be submitted by the Successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (Vide Works Department Letter No-14459/Dated 20-09-2018,Govt of Odisha,Works Department).As per office memorandum No 5992/Dt 27-04-2021 of Works Deptt. But if more than one bid is quoted at 14.99% less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concern Block Development Officer and the tender committee will remain present.
