
- Date of receipt and mode of submission of Tender papers:-** The Tenderers have to submit the sealed tender papers in complete shape through Registered Post/ Speed Post only, by directly sending it to the B.D.O, Anandapur in his official postal address. The last date of receipt of tender paper is **16.08.2021 up to 5 P.M.** The undersigned will not be responsible for postal delay if any or non receipt of the papers in time. **The tenders must super scribe the name of the work / project on the sealed envelope.**
- Date of Opening of Tender Paper:-** The tender paper shall be opened on 17.08.2021 at 11 A.M in the presence of the tenderers or their authorized representative having written authorization for the purpose and the tender committee.
- Document to be attached:-** The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
 - An Affidavit regarding Bid Security Declaration"
 - Self attested copy of Contractor Registration Certificate.
 - Self attested copy of PAN card/ Certificate of SGTIN.
 - Self attested copy of cast certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
 - The bidders have to produce an original affidavit in support of the authenticity of documents attached with the tender papers.
 - Joint venture consortium agreements are not allowed to participate in tender.
- Shortfall or any required documents(s) and Tender paper is liable for rejection.
- Additional Performance Security Deposit :** The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department Letter No. 14459/W Dt- 20.09.2018, Govt. of Odisha, Works Department.) As per office Memorandum No. 4559 Dated 05.04.2021 & office memorandum No. 5992/Dt. 27.04.2021 of works Deptt. Govt. of Odisha modification to APS will be followed as detailed below.

- Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

- If the rate quoted by the bidder is more less than (14.99%Less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99 %(Decimal up to two numbers will be taken for practical purpose) less than the estimated cost the tendered accepting authorities will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concerned Block Development Officer and the tender committee will remain present.




