Sealed quotation are invited by Speed post/Registered post only from interested reputed bidders/quotationer viz- Travel Agencies/Tour Operators or private individuals for providing on diesel driven Bolero or equivalent vehicle including driver, which shall confirm to the Terms and conditions (Annexure-II) for official use by Block Development Officer, Banspal, dist- Keonjhar on monthly rent basis:

1. The vehicle must be in Road Worthy conditions, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, Insurance certificate, Fitness certificate, valid contract carriage permit, proof of up-to-date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid Driving license for driving light transport passenger vehicle and should be sufficient experience in driving transport passenger vehicle.
3. The Driver should be well behaved,gentle and obedient in nature.
4. A sum of Rs. 5000/- shall be deposited by the intending bidders in shape of Account Payee Bank draft drawn in favour of the Block Development Officer, Banspalpayble at Keonjhar and submitted along with the quotation as security deposit. After completion of quotation process, the amount will be refunded to the unsuccessful bidders.
5. The vehicle must achieve a fuel efficiency minimum average mileage of 10 kms per litre.
6. The details of the make and year of manufacture of the vehicle, registration no. mileage (Kms. Covered per litre) and name of the Driver and Mobile No. with driving license No. and period of validity should be specifically provided in the general bid information to be furnished with the quotation (Annexure-III). Quotation will be finalized on the basis lowest rate quoted with all valid documents as per annexure -III and as per Government guidelines.
7. The Monthly rate of hire charge to quoted separately in price bid of the general bid information (excluding fuel and lubricants) Annexure-III.

The quotation completed in all respect and super scribed on the top of the envelop i.e., "QUOTATION FOR VEHICLE ON HIRING BASIS IN BLOCK DEVELOPMENT OFFICE, BANSPAL "should be reached to the O/o Block Development Officer, Banspal, Keonjhar on or before 15.09.2021 by 2.00 PM. and shall be opened on the same day at 3.00PM in presence all bidders/quotationers or their authorized representatives in the office of the undersigned.

**TERMS & CONDITIONS FOR HIRING OF VEHICLES.**

*The following terms and conditions must be fulfilled by the successful bidder for providing a vehicle on hire on monthly rent basis.*

1. The hired vehicles, during period of contract, shall have all necessary valid MV documents such as: - Valid Registration Certificate, Insurance certificate, Fitness Certificate, Valid Contract Carriage Permit, proof of up-to-date Tax payment etc. and Driving License (DL) of the driver available all the times. The department/ Office hiring the vehicle shall not be responsible for any damage/loss caused to hired vehicles or loss of life /injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The owner of the vehicle shall be responsible for all such litigation.
2. The hire charges to be paid are final but do not include cost of diesel, which is to be paid separately basing on actual consumption and lubricants as per existing Government norms. All the expenditure of the vehicle towards repair, replacement of spare parts, lubricating oil or Engine, Gear Box & different Coolant, Tyres & tubes, Battery etc. will be borne by the Bidder/quotationer.
3. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner of the vehicle.
4. In case of breakdown for reasons whatsoever the replacement of a vehicle of the same or better model shall be provided by the owner of the vehicle /bidder.
5. In case of vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage a new vehicle from other source.
6. The vehicle shall report for duty for 24x7days throughout the month in the office. The driver must not be a drunken person, must be a well behaved, obedient and gentle in nature.
7. In case of exigency, the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded/paid.
8. Monthly hire charges and reimbursements towards cost of diesel (as per actual) and lubricants (as per State Gov. norms) of selected bidder will be paid in every succeeding month, as far as possible within fifteen days of the submission of bills by the service provider/owner of the vehicle and no advance payment will be made.
9. The vehicle shall not be more than three years old from the initial registration and also in good running condition during the period of contract.
10. If the services are found to be unsatisfactory, the client shall give on month notice and terminate the agreement for fresh quotations.
11. In case the service provider intends to withdraw the services of his vehicle and terminate the agreement, it shall mandatory upon him to grant One Month Prior Notice before such withdrawal of service and termination of agreement.
12. If the bidder violates any of the terms of contract, Government shall forfeit the entire amount of security deposit.
13. The application form must be signed by the vehicle owner or bidder and properly sealed and also attached all relevant documents including drafts as per the terms and conditions.
