Terms and Conditions

- 1 Cost of tender paper:** The tender specification can be obtained from the office of the Block Development Officer, Jhumpura on Payment towards the cost of Tender papers as mentioned above(non refundable) in shape of bank draft or demand draft only(no other modes will be entertained) drawn in favour of Block Development Officer, Jhumpura in any nationalized bank having its branch at Jhumpura on any working day from Date 20.11.2021 to Date 04.12.2021 for the above work.
- 2 Sale of Tender Papers:** The tender documents will be sold from Date 20.11.2021 to Date 04.12.2021 at Block office, Jhumpura between 11.00 AM to 05.00 PM on working days only.
- 3 Date of receipt and mode of submission of tender paper:** The tenderers have to submit the sealed tender papers in complete shape through registered post/ speed post only by directly sending to the BDO, Jhumpura in his official postal address. The last date of receipt of tender paper is Date 04.12.2021 up to 5 PM. The undersigned will not be responsible for postal delay if any or non receipt of the papers in time. The Tenders must super scribe the name of the work / Project on the sealed envelope.
- 4 Date of opening of Tender Papers:** The tender paper shall be opened. on Date 06.12.2021 at 11.00AM in the presence of tenderers or their authorized representative having written authorization for the purpose and the tender committee.
- 5 Documents to be attached:** The following documents to be furnished with the tender papers failing which the tender will be liable to rejection.
 - i) An affidavit regarding "Bid Security Declaration"
 - ii Self attested copy of Contractor Registration Certificate.
 - iii) Self attested copy of PAN card and certificate of GSTIN.

- iv) Original Money receipt granted by BDO, Jhumpura towards cost of tender paper.
- v) Attested copy of cast certificate issued by competent authority in case of SC, ST contractors desirous of availing preference.
- vi) The bidders have to Produce an original affidavit in support of authenticity of documents including EMD, etc attached with the tender papers.
- vii) Affidavit as regards the facts of availing award work without submission of EMD/ ISD/ during the current financial year in case of Engineer Contractors desirous of availing exemptions of EMD otherwise their tender papers will be liable for rejection.
- viii) Joint venture consortium agreements are not allowed to participate in tender.

- 8 Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.
- 9 The block development Officer, Jhumpura reserve the right to reject any or all the tenders without assigning any reasons thereof other details can be seen in the bidding documents.
- 10 If the rate quoted by the bidder is more or less than (14.99% less) of the tendered amount, then such a bid shall be rejected or the tender shall be finalized basing on the merits of rest bids. But if more than one bid is quoted at 14.99 % (Decimal up to two numbers will be taken for all practical purposes) less than the estimated cost, the tendered accepting authorities will finalize the tender through a transparent lottery system where all the bidders/ authorized representatives, the concerned BDO and tender committee will remain present.






