2. Bidders are requested to submit the bid document along with the deposit the requisite non-refundable fees as mentioned in **column-05** in shape of demand draft from any nationalized Bank payable to Telkoi drawn in favour of BDO, Telkoi or else the tender paper will be rejected.
3. The tender paper will be received by **registered post/speed post** only up to 1.00 PM till date-09.12.2021 on working day. **The tenderer must superscribe the name of the work/project on the sealed envelop.**
4. The tender paper shall be opened by the BDO, Telkoi/his authorised officer in presence of the tenderer or their authorize agents on the schedule date and time as mentioned below.

  - B. Last date of receipt of Tender Paper: 09.12.2021 till 1.00 PM in working days.
  - C. Date and time of opening of Tender Paper: 10.12.2021 at 11.00 AM.
5. **Documents to be attached** :The Following documents should be furnished with the Tender Papers failing which the tender will be liable to rejection.

- (a) An Affidavit regarding "Bid Security Declaration".
- (b) Self Attested copy of Contractor Registration Certificate.
- (c) Self Attested copy of PAN Card/Certificate of GSTIN.
- (d) Joint Venture consortium agreements are not allowed to participate in tender.
- (e) The bidders have to produce an original affidavit in support of the authenticity of documents attached with the tender papers.

6. The SC/ST bidders willing to avail the benefits allowed by Govt. to ST/SC candidates must furnish the XEROX COPY OF CASTE CERTIFICATE .

7. The authority will not be responsible for any postal delay even if despatched before due date.

8. If the rate quoted by the bidder is more less than (14.99% Less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99%


