
Advertisement for inviting expression of interest for supply of 4 weeks old LIT Birds (Chicks) for the scheme, "Livelihood support to farmers through Rural backyard Poultry Scheme Under State Plan 2021-22"

1. Referring to Letter no-10239,dated-17.8.2021 Special Secretary to Govt, F&ARD Department applications are invited from the registered Govt. poultry farms / reputed hatchery/ registered rearing unit suppliers for supply of Low Input Technology (LIT) Birds (Vanaraja/ Rainbow Rooster/ Kuroiler/ Chhabro/ Kalinga Brown / RIR) of 19050 numbers of 4 weeks unsexed Chicks at block head quarter of all blocks of Keonjhar (Sadar, Banspal, Telkoi, Patna, Saharpada, Harichandanpur, Ghatagaon, Anandapur, Ghasipura, Hatadihi, Jhumpura, Champua, Joda).
2. The cost of the Bird is Rs 65/- per Chicks of 4 week old.
3. The cost includes both packaging & transportation charges.
4. 50 no's of live good quality healthy Birds will be handed over to each beneficiary in two phases (25+25) with a gap of 3 months through the concerned BVO/ DD/AVAS.
5. The supplier will produce due vaccination certificate up to 4 weeks at the time of delivery/production of bill.
6. The supply order will be given by the CDVO Keonjhar.
7. The payment towards the Chicks cost for supply will be made only after receipt of proper quality & quantity certificate from both the beneficiary & veterinary doctor of the concerned block.
8. The last date of receipt of Expression of Interest is 22.1.2022.






