 - B. Last date of receipt of Tender Paper: 30.03.2022 till 5.30 PM in working days.
 - C. Date and time of opening of Tender Paper: 31.03.2022 at 11.00 AM.

5. **Documents to be attached :**The Following documents should be furnished with the Tender Papers failing which the tender will be liable to rejection.
- An Affidavit regarding "Bid Security Declaration".
 - Self Attested copy of Contractor Registration Certificate.
 - Self Attested copy of PAN Card/Certificate of GSTIN.
 - Joint Venture consortium agreements are not allowed to participate in tender.
 - The bidders have to produce an original affidavit in support of the authenticity of documents attached with the tender papers.
6. The SC/ST bidders willing to avail the benefits allowed by Govt. to ST/SC candidates must furnish the XEROX COPY OF CASTE CERTIFICATE .
7. The authority will not be responsible for any postal delay even if despatched before due date.
8. If the rate quoted by the bidder is more less than (14.99% Less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% (Decimal up to two numbers will be taken for practical purpose) less than the estimated cost, the tendered accepting authorities will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concerned Block Development Officer and the tender committee will remain present.
9. **Additional Performance Security Deposit :** The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract.(Vide Works Department Letter No.-14459/W Date-20.09.2018, Govt. Of Odisha,Works Department.)
