NOTIFICATION

Whereas, a meeting was held on 09.03.2022 at 05.00 P.M. under the Chairmanship of the undersigned with participation of associate departmental officers regarding Development of Baldev Jew Bada Danda of Keonjhar.


The existing major issues of Baladev Jew Bada Danda regarding unorganised parking of vehicles mostly due to truck parking at Baladev Jew Bada Danda were detailed discussed in the meeting and it was decided to develop a truck parking zone/hub at an identified site (Government Land) of 8.72 Acres in Nizgarg Village of Keonjhar Municipality by the side of N.H.-520 with suitable intervention and facilities. The Sub-Collector, Keonjhar, Regional Transport Officer, Keonjhar and Executive Officer, Keonjhar Municipality were directed to communicate with the Truck Owners Associations and enforce no parking at Baladev Jew Bada Danda at the earliest. Moreover, development of truck parking facilities will also be planned at strategic location in the district subsequently.

Now, therefore, in exercise of the powers conferred on me Under Section-115 & 116 of the Motor Vehicle Act, 1988, I Shri Ashish Thakare, IAS, District Magistrate and Collector-Cum-Chairman, Regional Transport Authority, Keonjhar do hereby declared as prohibited areas for Heavy Goods Vehicles (Loaded & Unloaded) in **both Corridor of Bada Danda i.e. from Baldev Jew Mandir to Gundicha (Mausi Maa) Mandir** as **"NO PARKING ZONE"** and place the necessary signboards in aforesaid areas with immediate effect.
