

The Sealed quotations /tenders are invited from interested reputed Travel Agencies/Tour Operators or private individuals for providing one no. of Non A/C diesel driven vehicles having sitting capacity not more than ten including driver, which shall conform to the Terms and conditions for **MOBILITY SUPPORT TO LADY SUPERVISORS** under **OMBADC** for ICDS office Anandapur on monthly rent basis for the year 2022-23

1. The vehicle must be in road worthy condition, shall not be more than 3 years old from the date of initial registration and must have valid registration certificate, insurance certificate, fitness certificate, valid contract carriage permit, proof of up to date tax payment etc. which are mandatory for plying of vehicle.
2. The driver of the vehicle must have a valid driving license for driving light transport passenger vehicle and should be sufficiently, experienced in driving transport vehicle.
3. The driver should be well behaved, gentle and obedient in nature.
4. The vehicle must achieve a fuel efficiency of 10KM per Litre.
5. In case of emergency, the driver will have to for duty as per the requirement of hirer. No extra payment shall be demanded.
6. The monthly rate of hiring charge is Rs.24,000/-(Rs.16000/- for hiring charges and Rs. 8000/- towards fuel charges).
7. The vehicle shall report for duty for minimum of 25 days in a month.
8. In case of breakdown for reasons whatsoever the replacement of the same or better model shall be provided by the vehicle owner/bidder.
9. If the services are found to be unsatisfactory, the client shall give one month notice & terminate the agreement.
10. In case the service provider intends to withdraw the services or his vehicle & terminate the vehicle, it shall be mandatory upon him to grant one month notice before such withdrawal for service & termination of agreement.
11. All the expenditure of the vehicle towards repair, replacement of spare parts, Lubricating of engine oil of Engine, Gear Box & differential Coolant, Tyres & Tubes, Battery etc. will be borne by the bidder.

12. The Office shall not be responsible for any damage/loss caused to hired vehicles or losses of life /injury made to any person or damage to any property on account of use of hired vehicle any manner whatsoever. The hirer shall responsible for all such litigation.
13. The details of the make and year of manufacturer of the vehicle registration no., mileage, (KM covered per Liter) and name of the driver with driving license No. and period of validity should be specifically provided in the general BID information to be furnished with the quotation/tender.
14. The quotation should be submitted in the address of Child Development Project Officer, Anandapur superscribing quotation for "MOBILITY SUPPORT TO LADY SUPERVISORS" on the top of the envelope.
15. Quotation completed in all respect should reach the undersigned on or before Dt. 13.4.2022 by 1 PM and shall be opened on 18.4.2022 in the Office chamber of the Sub-Collector, Anandapur at 11 A.M. in presense of the bidders or their authorized representatives.
