The quotations received vide this office Quotation Call Notice No.1389/Accounts dt.22.03.2022 are hereby cancelled due to lack of required documents in quotations and as per decision of the Quotation Committee.

Now therefore, re-quotations are hereby invited from interested reputed Travel Agencies/Tour Operators of private individuals for providing one TUV 300/Bolero/Sumo Gold/(AC/Non AC) Diesel/Petrol vehicle having sitting capacity not more than ten including driver shall confirm to the Terms & Conditions (**Annexure-I**) for official use of Block Development Officer, Saharpada on monthly rent basis.

1. The vehicle must be in road-worthy condition and *shall have registration certificate not prior to 31.03.2019* and must have valid Registration Certificate/Insurance Certificate, Fitness Certificate, valid contact Carriage Permit, proof of update tax payment etc which are mandatory for plying of vehicle.
2. GST Registration and GeM registration are compulsory for any service providers to provide hired vehicle to Govt office through GeM or open bidding.
3. The Driver of the Vehicle must have a valid Driving licence for driving light transport passenger vehicle and should be sufficiently experienced in driving transport passenger vehicle.
4. The driver should be well behaved, gentle and obedient in nature.
5. A sum of Rs.5,000.00(Rupees five thousand) only shall be deposited by the intending bidders in shape of Account Payee Bank Draft drawn in favour of Block Development Officer, Saharpada, District-Keonjhar and submitted along with the quotation as security deposit. After completion of tender process, the amount will be returned to the unsuccessful bidders.
6. The monthly rate of hire charges be quoted separately in the general bid information(Excluding fuel and lubricants)
7. The vehicle must achieve a fuel efficiency of 17 KMs/ltr (Petrol) or 10 KMs/ltr(Diesel). The monthly hire charge of the vehicle is maximum Rs.31,000/- (Rupees thirty one thousand) only.
8. The details of the make and year manufacture of the vehicle, registration no, mileage (KMs cover per litre both in AC and Non AC) and name of the Driver with Driving licence No. and period of validity should be specifically provided in the general information to be furnished with the Quotation (Annexure-II)
9. The quotation should be **submitted in the address of Block Development Officer, Saharpada, District-Keonjhar superscribing 'Quotation for vehicle on hiring basis' on the top of the envelope.**
10. The quotation completed in all respect should be reach the office of the Panchayat Samiti, Saharpada, District-Keonjhar **on 26.04.2022 and shall be opened on the same day at (time) 11.00 AM** before the Quotation Committee constituted for the purpose in the office chamber of the Block Development Officer, Saharpada in presence of the bidders or their authorized representatives.
11. The application form of quotation, tender containing general bid information and terms and conditions for hiring of vehicle etc. will be available in the district website www.kendujhar.nic.in which can be downloaded from the website.
12. All the Govt instructions / circulars issued from time to time will be carried out in respect of hiring and engagement of private vehicle.
13. The undersigned reserves the right to accept or reject or negotiate the quotation.







ANNEXURE-I

TERMS AND CONDITIONS FOR HIRING VEHICLE

The following terms and conditions must be fulfilled by the successful bidders for providing a vehicle on hire on monthly rent basis.

1. The successful bidder has to enter an agreement with the hirer for providing the vehicle with certain agreeable terms and conditions as laid down in the Finance Department Memorandum No.30464/F dated 06.09.2019.
2. The hired vehicle, during period of contract, shall have all necessary valid MV documents such as ; valid Registration Certificate, Insurance Certificate, Fitness Certificate, Valid Carriage Permit, proof of up to date tax payment and other certificate like Pollution free etc and DL of the driver available all the times. The office hiring vehicle shall not be responsible for any damage/loss caused to hired vehicle or loss of life / injury made to any persons or damages to any property on account of use of hired vehicle any manner whatsoever.
3. The hire charges to be paid for monthly basis is final but does not include cost of diesel which is to be paid separately basing on actual consumption of lubricants as per existing Govt norms. All the expenditure of the vehicle towards repair replacement of spare parts, lubricants oil of engine, gear box & different coolant tyres & tubes, battery etc will be borne by the bidder.
4. It shall be the responsibility of the bidder to provide a good driver and the salary of the driver shall be borne by the owner.
5. In case of breakdown for reasons whatsoever, the replacement of the vehicle of the same or better model shall be provided by the owner of the vehicle / bidder.
6. In case of the vehicle do not report regularly, the authority will be at liberty to reject the agreement and may engage vehicle from other sources.
7. The vehicle shall report for duty every day at 8.00 AM, after duty, the vehicle will be parked at owner's risk.
8. In case of emergency the driver will have to report for duty as per the requirement of hirer. No extra payment shall be demanded.
9. Monthly hire charges will be paid in every succeeding month, as far as possible, within fifteen days of the succeeding month and no advance payment will be made.
10. The vehicle shall have registration certificate **not prior to 31.03.2019** and also in good running condition during the period of contract.
11. If the services are found to be unsatisfactory, the client shall give one month notice and terminate the agreement.
12. In case of the service provider intends to withdraw the services of his/her vehicle and terminate the agreement, it shall be mandatory upon her/him to grant one month notice before such withdrawal of service and termination of agreement.
13. If the bidder violates any of the contracts/terms and conditions, the office shall forfeit the entire amount of security deposit.
14. The hirer of the vehicle reserves the right to add or delete any condition; if it is felt necessary during the time of execution of agreement.
