**NOTIFICATION**

2. AND WHEREAS the questions shall be dispatched from Nodal Centres to different Examination Centres during morning time on the date of examination. It may cause dislocation in conducting examination if heavy transport vehicles (both loaded/ empty) obstruct en-route.

AND WHEREAS the District Education Officer, Keonjhar in his letter no. 3093/DEO dated 22.04.2022 has requested of discontinuance movement of heavy transport vehicles (both loaded/ empty) on the date of SA-II (Class-X) Examination'2022 i.e from 29.04.2022 to 07.05.2022 from 05.00 AM to 10.00 AM for easy passage of vehicles carrying confidential packets to the examination centres as well as movement of examinees.



Now, therefore, in exercise of powers conferred on me by section 115 of Motor Vehicle Act, 1988, I, Sushama Bilung, OAS, being the District Magistrate and Collector (I/C), Additional District Magistrate, Keonjhar, do hereby restrict movement of heavy transport vehicles carrying (both loaded/ empty) passing through (1). Suakati, Banspal to Keonjhar Town (2) Bileipada to Bolani of Joda Block, (3) Bileipada to Bamebari of Joda Block in the district of Keonjhar for the period from 29.04.2022 to 07.05.2022 within 05.00 AM to 10.00 AM for easy passage of vehicles carrying confidential packets to the examination centres as well as movement of examinees.


