If the office happens to be closed on the date of receipt / opening of the bids as specified, above will be received / opened on the next working day at the same time and venue.

3. Bidders are requested to submit the bid document along with the deposit the requisite non-refundable fees as mentioned in Col. 7 in shape of Demand Draft drawn in favour of Block Development Officer, Sadar, Keonjhar payable at Sadar, Keonjhar from any Nationalized scheduled Bank towards cost of tender paper. This is non-refundable..

4. Documents to be attached: The following documents should be furnished with the Tender Papers failing which the tender will be liable to rejection.

- a) An Affidavite regarding "Bid security Declaration"
- b) attested true copy of valid registration certificate,
- c) Self Attested copy of PAN Card /Certificate of GSTIN
- d) Self Attested copy of Certificate of GSTIN
- e) Joint venture consortium agreements are not allowed to participate in tender.
- f) The Bidders have to produce an original affidavit in support of the authenticity of documents attached with tender papers..

The original certificates of the lowest two bidders are to be produced before Executive Engineer, DRDA, Keonjhar for verification.

6. Checklist is to be duly filled in.

7. The ST/SC contractor desires to avail price preference will have to deposit the Additional performance security before commencement of Aggrement otherwise the bid will not be taken into consideration and liable for reject.

8. The name of work for which and the authority to which the tender is being submitted must be mentioned in the affidavit failing, which the tender will be rejected.

9. Additional performance Security Deposit:

The affidavit in lieu of APS will be submitted by the Successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (Vide Works Department Letter No-14459/W Dated 20-09-2018, Govt of Odisha, Works Department)

As per office Memorandum No 4559 dated 05.04.2021 of works Deptt. Govt. of Odisha Modification to APS will be followed as detailed below:-

10. Conditional tender will summarily be rejected.

11. If the rate quoted by the bidder is more than (14.99% less) of the tendered amount then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% less than the estimated cost the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concern Block Development Officer and the tender committee will remain present.

12. The authority reserves the rights to reject any or all the bids without assigning any reason thereof.
