NOTIFICATION

WHEREAS the District Education Officer, Keonjhar has intimated that, the AHSC Exam. SA-I (Class-X), Madhyama Examination and SOSC Examination'2022 will commence from 23.11.2022 to 30.11.2022.

2. AND WHEREAS the questions shall be dispatched from Nodal Centres to different Examination Centres during morning time on the date of examination. It may cause dislocation in conducting examination if heavy transport vehicles (both loaded/ empty) obstruct en-route.

AND WHEREAS the District Education Officer, Keonjhar in his letter no. 13644/DEO/AHSC/SA-1/2022 dated 18.11.2022 has requested for discontinuance movement of heavy transport vehicles (both loaded/ empty) on the date of AHSC Exam. SA-I (Class-X), Madhyama Examination and SOSC Examination'2022 i.e from 23.11.2022 to 30.11.2022 from 05.00 AM to 09.00 AM for easy passage of vehicles carrying confidential packets to the examination centres as well as movement of examinees.

Now, therefore, in exercise of powers conferred on me by section 115 of Motor Vehicle Act, 1988, I, Shri Ashish Thakare, IAS, District Magistrate and Collector-cum-Chairman, Regional Transport Authority, Keonjhar, do hereby ordered to restrict movement of heavy transport vehicles carrying (both loaded/ empty) passing through (1) Suakati, Banspal to Keonjhar Town (2) Bileipada to Barbil MPL of Joda Block, (3) Bileipada to Bamebari, Basantpur of Joda Block in the district of Keonjhar for the period from 05.00 AM to 10.00 AM from 23.11.2022 to 31.11.2022 for easy passage of vehicles carrying confidential packets to the examination centres as well as movement of examinees.
