**Advertisement for inviting expression of interest for supply of 4weeks old LIT Birds(Chicks) for the scheme" Livelihood Support to Farmers through Rural Backyard Poultry Scheme under State Plan 2022-23**

1. Referring to letter no-7524(30)dated- 26.06.2022 Directorate AH & VS, Odisha, Cuttack & decision taken in DLC meeting held under Chairmanship of CDVO, Keonjhar sealed quotation is invited from the registered Govt poultry farms/ Govt Poultry hatchery /registered chick rearing unit suppliers /registered poultry hatcheries for supply of Low Input Technology (LIT) Birds (Vanaraja/Rainbow Rooster/Kuroiler/Chhabro/Kalinga Brown/RIR) of 57500 numbers of 4weeks unsexed birds at block head quarter of all blocks of Keonjhar (Keonjhar Sadar, Banspal, Telkoi, Patna, Saharapada, Harichandanpur, Ghatagaon, Anandapur, Ghasipura, Hatadihi, Jhumpura, Champua & Joda).
2. The cost of Bird is Rs 65/- per bird of 4weeks old.
3. The cost of bird includes both packaging , transportation loading & unloading of birds.
4. 50 nos of live good quality healthy Birds with minimum 250grams of weight each bird at the time of delivery will be handed over to each beneficiary in two phases (25+25) with a gap of 3 months through the concerned BVO/DD, DVH/AVAS
5. The supplier will produce due vaccination certificate up to 4 weeks at the time of delivery/production of bill.
6. The supply order will be given by the CDVO, Keonjhar
7. The payment towards the chicks cost for supply will be made only after receipt of proper quality & quantity certificate from both the beneficiary & DD/BVO of the concerned block.
8. Sealed quotation will be received through registered post/courier only at CDVO, Office, Keonjhar in working hours on or before 05.12.2022 at 4PM.
