**NOTIFICATION**

WHEREAS, as per decision taken in the meeting held on 19.07.2019 at 03.00 PM in the Conference Hall of Sub-Collector, Champua, Dist-Keonjhar regarding vehicular movement and road development.

AND WHEREAS, it is observed that the Tippers, Trucks are not moving systematically causing heavy traffic jam for which the public are facing lot of problems in their daily routine life, especially the school going children/ patient are not reached the destination in due time. Similarly the brakes down vehicles are stand upon the road and caused traffic jam.

NOW, THEREFORE, in exercise of powers conferred on me by Section-115 of Motor vehicle Act'1988, I, Shri Ashish Thakare, IAS, Collector and District Magistrate-cum-Chairman, RTA, Keonjhar, do hereby re-restrict the movement of Heavy Goods Vehicles except vehicles carrying essential commodities on the following state / PWD Road in the Joda, Barbil & Champua areas:

**AREA- Rugudi to Bileipada**

Restriction time- 08.00 A.M to 11.00 AM and 03.00 PM to 08.00 PM  
Relaxation time- 11.00 AM to 03.00 PM and 08.00 PM to 08.00 AM  
Every Sunday relaxation for all vehicles for whole day.

**Bileipada to Tarini Chhak**

Restriction time: 08.00 AM to 11.00 AM and 03.00 PM to 08.00 PM  
Allowed time : 08.00 PM to 08.00 AM and 11.00 AM to 03.00 PM

**JODA Municipality**

Restriction time: 06.00 AM to 02.00 PM and 03.00 PM to 8.00 PM  
Allowed time : 08.00 PM to 06.00 AM and 02.00 PM to 03.00 PM

**BARBIL Municipality**

Restriction time: 06.00 AM to 02.00 PM and 03.00 PM to 08.00 PM  
Allowed time : 08.00 PM to 06.00 AM and 02.00 PM to 03.00 PM
