The Divisional Forest Officer, Keonjhar Division on behalf of Governor of Odisha invites bids in Double Cover System in online mode from the Registered manufacture/ Authorised dealer of Tensile Fabric registered with the State Government and bidders of equivalent Grade / Class registered with Central Government / MES / Railways for the works detailed in the table below on turn key basis (i.e. with design and execution). The agency has to follow the instruction of the Divisional Forest Officer, Keonjhar Division for supply & installation of Tensile Fabric Cottage structure

3. The Bidders shall be a registered manufacturer/Authorized dealer of Tensile Fabric Structures

4. The Bidders not registered with Govt. of Odisha, should be registered under Odisha Govt. before the award of contract failing which the bid security shall be forfeited the said bid stands cancelled

8. The Bidder must possess **Compatible Digital Signature Certificate (DSC) of Class II or Class III.**

9. Bids shall be received only **“On-line”** on or before **17.00 Hours of 14.02.2023.**

10. The bids must be delivered in the Tender Box having Identification No. FE&CC-DFO(T) KJR- 04 / 2022-23 kept in the O/O the Divisional Forest Officer, Keonjhar Division

11. Bids received on line shall be opened at **11.30 Hours on 15.02.2023** in the office of the Divisional Forest Officer, Keonjhar Division, Keonjhar, Odisha in the presence of the bidders who wish to attend. Bidders who participated in the bid can witness the opening of bids after logging on to the site through their DSC. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue.

12. The bidder shall transfer online the cost of bid document as shown in **column No. 4** above against each work through a process as mentioned under DTCN.

13. The bidder shall submit scanned copy of GST Registration Certificate and GSTIN, scanned copy of registration certificate, PAN card, affidavit and documents required as per the relevant clauses of this DTCN

14. The bidder is required to visit the site before offering the BID. arding the design, drawing, details of specification alongwith other requirement before the tender committee.

15. The bidder should have the technical competency to design such structure and shall have structural design facilities for the same. The bidder shall submit detailed design & drawing along with bid. They will have to make one power point presentation regarding the design, drawing, details of specification alongwith other requirement before the tender committee after opening of the technical BID.

16. The bidders shall not write their name on the cover containing bids & other ancillary documents submitted. Only name of work shall be written on it

17. Other details can be seen in the bid documents.
