Terms and Conditions:

1. **Cost of Tender paper** : The Tender specification can be obtained from www.kendujhar.nic.in in official site of the Kendujhar District and submit cost of Tender papers as mentioned above (Non-Refundable) in shape of Bank Draft or Demand Draft only (No other modes will be entertained) drawn in favour of Block Development Officer, Joda in any Nationalized Bank having its branch at Joda along with Tender Application form from .04-02-2023 for the above work.
2. **Sale of Tender papers** : The Tender documents will be available in www.kendujhar.nic.in from 04-02-2023 TO 19-02-2023 . The interested Bidders are requested to avail their application form the said website only. No provision of Physical sale of Tender papers is at Panchayat Samiti Joda.
3. **Date of receipt and mode of submission of Tender papers** : The Tenderers have to submit the sealed tender papers in complete shape through **Registered Post/Speed post** only, by directly sending it to the B.D.O, Joda in his official postal address. The last date of receipt of tender papers is **21-02-2023 upto 2.00 P.M.** The undersigned will not be responsible for postal delay if any or non receipt of the papers in time. **The tenders must superscribe the name of the work/project on the sealed envelope in Capital Letter.**
4. **Date of Opening of Tender Paper** : The tender paper shall be opened on **22-02-2023 at 9.00 AM** in the presence of the tenderers or their authorized representative having written authorization for the purpose and the tender committee.
5. **Documents to be attached:** The following document should be furnished with the tender papers failing which the tender will be liable to rejection.
 - (a) E.M.D pledged in favour of the Block Development Officer, Joda.
 - (b) Attested copy of Contractor Registration Certificate.
 - (c) Attested copy of PAN card and Certificate of GSTIN.
 - (d) D.D for Cost of Tender Paper.
 - (e) Attested copy of cast certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
 - (f) The bidders have to produce an original affidavit in support of the authenticity of documents including EMD, etc attached with the tender papers.

(g) Affidavit as regards the facts of availing award of work without submission of EMD/ISD during the current financial year in case of Engineer Contractors desirous of availing exemption of EMD otherwise their tender paper will be liable for rejection.

(h) Joint venture consortium agreements are not allowed to participate in tender.

6. Shortfall of any required document(s) and EMD, Tender paper is liable for rejection.

7. Additional Performance Security Deposit : The affidavit in lieu of APS will be submitted by the successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract. (Vide Works Department Letter No.-14459 Date-20/09/2018, Govt. of Odisha, Works Department.) As per the Memorandum No 4559 Dt. 05.04.2021 of Works Deptt Govt. of Odisha modified to APS will be followed as detailed below:

8. Forfeiture : The EMD amount will be forfeited, if the tenderer backs out from the offer acceptance of tender, by the competent authority.

9. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such Tender papers.

10. If the rate quoted by the bidder is more than (14.99 % less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of the rest bids. But if more than one bid is quoted at 14.99 % (Decimal up to two numbers will be taken for practical purpose) less than the estimated cost, the tendered accepting authorities will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concerned Block Development officer and tender committee will remain present.

11. The Block Development Officer, Joda reserve the right to reject any or all the tenders without assigning any Reasons thereof. Other details can be seen in the bidding documents.

12. The Successful bidder shall sign an agreement with BDO, Joda in the non-judicial paper of worth Rs.200/- (Rupees two hundred) only for executing the work.
