SHORT QUOTATION CALL NOTICE

Sealed quotation in plain paper are invited from the authorized dealers/ distributors/supplier for supply of infertility camp medicines for field institution to organize 45 infertility camps in Keonjhar District, which should be completed within March 2023. The list of all items with detail specification eligibility criteria & quotation term & condition are annexed herewith. The sealed quotation will be received by speed post or by hand only on or before 13.03.2023 till 2PM & the quotation will be opened on 14.03.2023 at 11AM in presence of bidders or their authorized representatives. Absence of bidders/authorized representatives will not be a bar to open the quotations received. The quotation received incomplete & after scheduled date & time shall be rejected. Rates should be quoted for each items including GST & other taxes & the items are to be delivered at O/O CDVO, Keonjhar. The undersigned reserves right to reject any or all quotation without assigning any reason thereof. All legal disputes if any relating to the quotation are subject to jurisdiction of court of law of Keonjhar district.

PREQUALIFICATION FOR QUOTATION

1. The participating bidder should be an authorized Dealer/Distributor/supplier having valid drug license & GST registration.
2. The participating bidder who has been blacklisted by the State Govt/Central Govt/any PSU is not eligible to participate in this procurement process through quotation.
3. Agencies/bidders of Odisha State only are allowed for bidding.

TERMS & CONDITION OF QUOTATION

1. The quotation should be neatly type written with each page of quotation paper should be numbered.
2. Sealed quotation must be super scribed over envelope as **quotation for supply of medicines**.
3. Any corrections/ overwriting in quotations is not accepted.
4. Supply should be made at the O/O CDVO, Keonjhar within 07 days of receiving supply order.
5. The bidder should have a valid drug licence.
6. The bidder should have valid GST registration certificate of Odisha state.
7. The bidder should enclose self-attested copy of PAN, copy of valid drug license, GST registration certificate & GST clearance for last quarter.
8. The bidder can submit their quotation for individual or multiple items intend to supply from the list of medicines mentioned below inclusive of all taxes.
9. The tax will be charged as per Govt. guideline.
10. The payment shall be made after delivery of items in proper condition & as per specification through RTGS after submission of bills/vouchers. The bank details of the bidders should be mentioned on the body of bill.
11. Medicines supplied shall not have expiry date less than one year.
12. The rate contract once approved should remain valid for one year from the date of approval.
13. The bidder should give a self-declaration in his office letter pad that he has not been blacklisted by the state Govt /Central Govt/any PSU.
14. Must produce original drug licence & GST certificate for verification prior to agreement.
15. Agencies/bidders of Odisha State only are allowed for bidding.
