

**Terms and Conditions:**

1. The tender document (DTCN & BOQ) can be obtained/downloaded from district NIC Website ([www.kendujhar.nic.in](http://www.kendujhar.nic.in)) from Dt.15.03.2023 to 28.03.2023 till 5.00P.M.
2. The tender document (DTCN & BOQ) duly signed by the Contractors should be accompanied with the self-attested photocopy of valid GST Clearance certificate, PAN card, Registration Certificate and requisite EMD in shape of Demand Draft drawn in favour of BDO, GHATAGOAN" payable at "Keonjhar" from any Nationalized Bank having its branch at Keonjhar and NSC/ KVP/ Time Deposit duly pledged.
3. The tender document (DTCN & BOQ) should accompanied with requisite tender paper cost (Non-Refundable) as mentioned in Col-6 of Annexure-I in shape of Bank Draft drawn in favour of BDO, GHATAGOAN" payable at "Keonjhar" from any Nationalized Bank having its branch at Keonjhar.
4. The tenders will be received up to dt.29.03.2023 till 5.00 p.m. and addressed to the Block Development officer, At/P.O.-Ghatgaon, Dist.-Keonjhar, PIN-758027 through Registered/Speed Post only.
5. The tender is scheduled to be opened on Dt-31.03.2023 at 11.00 A.M. at Block Conference Hall, O/o the Block Development officer, Ghatgaon, Keonjhar, 758027 in presence of the tenderers or their authorized representatives. If the office happens to be closed on the date of

receipt/opening of the bids as specified above, then it will be received/opened on the next working day at the same time and venue.

6. **Documents to be attached:-** The following document should be furnished with the tender papers failing which the tender will be liable for rejection.
- a) An Affidavit regarding "Bid Security Declaration" should be furnished clearly as per latest circular No-5984/W/Dt-27-04-2021 of Works Deptt., Govt. of Odisha so as to avail exemption of EMD.
  - b) An affidavit showing that the tenderer is not under any litigation with Government presently.
  - c) Self-attested copy of Contractor Registration Certificate.
  - d) Self-attested copy of valid GSTIN Certificate and PAN card.
  - e) Self-attested copy of Caste Certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.
  - f) The Bidders shall submit original affidavit regarding authenticity of their documents attached with the tender papers.
  - g) Joint venture consortium agreements are not allowed to participate in tender.
  - h) Bid security @ 2% of contract value shall be pledged in parts in favour of **Block Development Officer, Ghatgaon** corresponding to the respective value of works.
  - i) Cost of Tender Paper in shape of Bank Draft drawn in favour of BDO, GHATAGOAN towards.
7. Checklist is to be duly filled in. Shortfall of any requisite document(s) and Tender paper is liable for rejection.
8. Engineer Contractors desirous to avail the facility of exemption of E.M.D. are required to submit an affidavit to the effect that he has not yet availed such facility for more than two works during the current financial year. The name of the work/project awarded by the Executing Authority or any tender submitted to the Executing Authority must be mentioned in the affidavit failing which the tender will be rejected.



9. **Additional performance Security Deposit:**

The affidavit in lieu of APS will be submitted by the Successful bidder for the cost of less quoted in percentage of the amount put to tender before the signing of the agreement of the contract (Vide Works Department Letter No-16659/Dated 20-09-2018, Govt. of Odisha, Works Department). As per office memorandum No.-5992/Dt 27-04-2021 of Works Deptt. Govt of Odisha modification to APS will be followed as detailed below:-

10. Conditional tender will summarily be rejected.
11. If the rate quoted by the bidder is more than (14.99% less) of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at 14.99% less than the estimated cost, the tender accepting authority will finalize the tender through a transparent lottery system where all bidders/authorized representatives, the concern Block Development Officer and the tender committee will remain present.
12. The envelope containing the tender paper must be superscribed the name of the work on the top of the envelope.
13. The authority reserves the rights to reject any or all the bids without assigning any reason thereof.
