The tenders will be received up to Dt. 14.02.2023 till 5.00 p.m. and addressed to O/O Block Development officer, Anandapur, Keonjhar, 758021 through Registered/Speed Post. The tender is scheduled to be opened on Dt 16.02.2023 at 11.00 a.m. at Block Conference Hall, O/O the Block Development officer, Anandapur, Keonjhar in presence of the tenderers or their authorized representatives. Terms and Conditions:

1. Date of receipt and mode of submission of Tender papers: The Tenderers have to submit the sealed tender papers in complete shape through Registered Post/Speed post only, by directly sending it to the B.D.O, Anandapur in his official postal address. The last date of receipt of tender paper is 14.02.2023 up to 5.00 P.M. The undersigned will not be responsible for postal delay if any non receipt of the papers in time. **The tenders must super scribe the name of the work/project on the sealed envelope.**

2. Date of Opening of Tender Paper: The tender paper shall be opened on 16.02.2023 at 11.00 A.M in the presence of the tenderers or their authorized representative having written authorization for the purpose and the tender committee.

3. As per codal provision works more than Rs.50.00 lakhs should be in Double cover mode (as per letter No. 01/WR dt. 01.01.2019 i.e. Cover-I contains (Technical Bid) Cover-II contains (Financial Bid) to be fill up separately indicating therein as "Cover-I and Cover-II" respectively and finally put together in one Cover. After due scrutiny of Cover-I, the Cover-II will be opened. Works experience certificate for similar nature of work. Those bidders have no experience certificate which the tender will be rejected.

4. **1st Cover (Technical):** Tender cost, EMD, GSTN, PAN, Contractor's RC, Affidavit and any other documents as per DTCN (in PDF format).

5. **2nd Cover (Financial):** Bill of Quantities (BOQ), Additional Performance Security, if applicable.

6. For Earnest Money Deposit (EMD), the tenderers are required to give 1% of the Tender Value.

7. Documents to be attached: The following document should be furnished with the tender papers failing which the tender will be liable to rejection.

(a) Self attested copy of Contractor Registration Certificate.

(b) Self attested copy of PAN card/Certificate of GSTIN.

(c) Self attested copy of cast certificate issued by competent authorities in case of SC/ST contractors desirous of availing preference.

(d) The bidders have to produce an original affidavit in support of the authenticity of documents attached with the tender Papers.

(e) Joint venture consortium agreements are not allowed to participate in tender.

8. Shortfall of any required document(s) and Tender paper is liable for rejection.

9. Additional Performance Security Deposit: The affidavit in lieu of APS will be submitted by the successful bidder for the cost less quoted in percentage of the amount put to tender before signing of the agreement of the contract. (Vide Works Department Letter No. -14459/W Date-20.09.2018, Govt. of Odisha, Works Department.) As per office Memorandum No 4559 Dated 05.04.2021 & office Memorandum No 5992/ Dt. 27.04.2021 of works Deptt. Govt. of Odisha modification to APS will be followed as detailed below:-

10. Submission of more than one tender paper by a bidder for a single work will be liable for rejection of all such tender papers.

11. The Block Development Officer, Anandapur reserve the right to reject any or all the tenders without assigning any Reason thereof. Other details can be seen in the bidding documents.

12. If the rate quoted by the bidder is **more less than (14.99% Less)** of the tendered amount, then such a bid shall be rejected and the tender shall be finalized basing on merits of rest bids. But if more than one bid is quoted at **14.99% (Decimal up to two number will be taken for practical purpose)** less than the estimated cost, the tendered accepting authorities will finalize the tender through transparent lottery system where all bidders/authorized representatives, the concerned Block Development Officer and the tender committee will remain present.




